### RE-ORGANIZING THE PLANNING TEAM FOR THE ISABELA LOCAL INVESTMENT PLAN FOR HEALTH AND THE ANNUAL OPERATIONAL PLAN

**WHEREAS**, the Department of Interior and Local Government (DILG) in Joint Memorandum Circular No. 2007-001 provides guidelines on the harmonization of local planning, investment programming, revenue administration, budgeting & expenditure management and strengthen the interface between local government units (LGUs) and national government agencies (NGAs);

**WHEREAS**, pursuant to relevant provisions of the Local Government Code (LGC) of 1991, all LGUs shall prepare their comprehensive development plans, Local Development Investment Programs (LDIPs), Annual Investment Programs (AIPs), Annual and Supplemental Budgets in the context of and in harmony with national and regional policies, goals and strategies;

**WHEREAS**, the LIPH and AOP shall reflect health needs of the barangays, cities and municipalities are integrated to develop province-wide health plan to ensure equitable, effective and efficient health care;

**WHEREAS**, there is a need to reconstitute the Planning Team for the Isabela Local Investment Plan for Health and the Annual Operational Plan for the continuing effective implementation of the health programs of the Provincial Government of Isabela;

**NOW THEREFORE**, I, Rodolfo T. Albano III, Governor of the Province of Isabela, by virtue of the powers vested in me by law, hereby decree the following:

**Section 1. Re-organization.** THE PLANNING TEAM FOR THE ISABELA LOCAL INVESTMENT PLAN FOR HEALTH (LIPH) AND THE ANNUAL OPERATIONAL PLAN (AOP) is hereby re-organized.
