REORGANIZING THE COMPREHENSIVE DEVELOPMENT PLAN TECHNICAL ASSESSMENT OF COMMITTEE (CDP-TAC) AND TECHNICAL ASSESSMENT COMMITTEE SECRETARIAT (TACS) FOR THE ASSESSMENT OF THE CDPs OF COMPONENT CITIES AND MUNICIPALITIES PROVIDING FOR ITS COMPOSITION, ROLES AND RESPONSIBILITIES

WHEREAS, Republic Act No. 7160 or the Local Government Code of 1991 mandates all cities and municipalities to prepare a Comprehensive Development Plan (CDP) that outlines the key goals and objectives, challenges, and concerns facing local government units and identifies a set of programs, projects and policies to attain its vision and mission towards a sustainable and holistic socio-economic development;

WHEREAS, DILG Memorandum Circular 2018-172 Comprehensive Development Plan Assessment for Component Cities and Municipalities provides that the Provincial Development Council thru a Special Functional Committee created for the purpose, shall assess the CDPs of its component cities and municipalities for compliance to established guidelines on the formulation of CDP; its alignment with the Provincial Development and Physical Framework Plan, Provincial Development Investment Program, Comprehensive Land Use Plan; and to national development thrusts and strategic directions as part of the province's share oversight function with concerned national government agencies;

WHEREAS, the separation, transfer and/or promotion from office of the members of the CDP-TAC, have resulted in vacancies in the membership of the committee;

WHEREAS, there is a need to reconstitute the CDP-TAC to ensure its continuing mandate and functions;

NOW THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by the powers vested in me by law, do hereby order the reorganization of the CDP-TAC, as follows:
