REORGANIZING THE PROVINCIAL DEVELOPMENT COUNCIL OF THE PROVINCE OF ISABELA

WHEREAS, Section 106 of Republic Act 7160, otherwise known as the “Local Government Code of 1991,” provides for the organization of local development councils that will initiate a comprehensive multi-sectoral development plan to be approved by their corresponding legislative board or Sanggunian;

WHEREAS, the local development council at the provincial, city, municipal, and barangay level, shall assist the corresponding Sanggunian in setting the direction of economic and social development, and in coordinating development efforts within its territorial jurisdiction;

WHEREAS, the separation, transfer, and/or promotion from the office of the members of the Provincial Development Council for the period July 2019 thru June 2022 warrants the reorganization and reconstitution of the Provincial Development Council of the Province of Isabela;

NOW, THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by virtue of the authority vested in me by law, do hereby organize and reconstitute the Provincial Development Council of the Province of Isabela as follows:

SECTION 1. COMPOSITION. The Provincial Development Council of the Province of Isabela shall be composed of the following:

SECTION 2. FUNCTIONS OF THE PROVINCIAL DEVELOPMENT COUNCIL. The Provincial Development Council shall exercise the following functions:

- a. Formulate long-term, medium-term, and annual socio-economic development plans and policies;
- b. Formulate the medium-term and annual public investment programs;

- c. Appraise the prioritized socio-economic development programs and projects;
- d. Formulate local investment incentives to promote the inflow and direction of private investment capital;
- e. Coordinate, monitor, and evaluate the implementation of development programs and projects; and
- f. Perform such other functions as may be provided by law or competent authority.

SECTION 3. COMPOSITION OF THE PROVINCIAL DEVELOPMENT COUNCIL – EXECUTIVE COMMITTEE. The PDC EXECOM shall represent the Council and act on its behalf when it is not in session and shall be composed of the following:

SECTION 4. FUNCTIONS OF THE PROVINCIAL DEVELOPMENT COUNCIL-EXECUTIVE COMMITTEE (PDC-EXECOM). The following shall be the functions of the Provincial Development Council – Executive Committee (PDC-EXECOM):

1. Ensure that the decision of the Council is faithfully carried out and implemented;
2. Act in matters requiring immediate attention or action by the Council;
3. Formulate policies, plans, and programs based on the general principles laid down by the Council;
4. Act on other matters may be authorized by the Council;
5. Conduct regular meetings every end of the quarter, or as the need arises.

SECTION 5. SECTORAL COMMITTEE. There shall be created sectoral committee, namely the following, which shall be constituted by the PDC itself:

1. Social Sector
2. Economic Sector
3. Infrastructure Sector
4. Environmental Sector
5. Institutional Sector

SECTION 6. SECRETARIAT. There is hereby constituted a Secretariat to the Provincial Development Council to be composed of personnel from the Provincial Planning and Development Office who shall be responsible for providing technical support, documentation of proceedings, preparation of

reports, and such other assistance as may be required in the discharge of each function. It shall be composed as follows:

SECTION 7. SEPARABILITY CLAUSE. Should any provision of this Executive Order be declared invalid or unconstitutional by a Court of competent jurisdiction, the remaining provisions not otherwise adversely affected thereby shall remain in full force and effect.

SECTION 8. REPEALING CLAUSE. Any and all executive orders, issuance, rules, and regulations, memoranda of the Provincial Government of Isabela, or any part thereof which are inconsistent with the provision of this Executive Order are hereby repealed, amended, or modified accordingly.

SECTION 9. EFFECTIVITY. This Executive Order shall take effect immediately upon signing hereof and shall remain effective until revoked.
