### EXECUTIVE ORDER NO. 29-D Series of 2022

#### ADOPTING THE STANDARD OPERATING PROCEDURE ON THE END-TO-END EARLY WARNING SYSTEM AND FEEDBACKING MECHANISMS AND COMMUNICATION TO RESIDENCE IN HIGH RISK AREAS IN THE PROVINCE OF ISABELA

**WHEREAS**, it is the policy of the State to uphold the people's constitutional right to life and property by addressing the root causes of vulnerabilities to disasters, strengthening the country's institutional capacity for disaster risk reduction and management (DRRM), and building the resilience of local communities to disasters, including climate change impacts;

**WHEREAS**, Section 12 of Republic Act No. 10121 or the PDRRM Act of 2010, it is the function of the Local Risk Reduction and Management Council to manage the adverse effect of emergencies and carry out recovery activities in the affected areas;

**WHEREAS**, it is the duty of the Provincial Government of Isabela, as provided for in Republic Act 7160 or the Local Government Code, to carry out emergency measures as may be necessary during and in the aftermath of disasters and calamities;

**WHEREAS**, the institution of a Standard Operating Procedure on the end-to-end early warning system in different Hazards will enable the province to prepare and respond quickly, aptly and effectively before, during and after disaster or calamity;

**WHEREAS**, Standard Operating Procedure on the end-to-end early warning system was designed as pre-emptive measure to any kind of disaster and calamities to ensure maximum safety precaution and to lessen the impact of losses both to life and properties;

**WHEREAS**, the province shall adopt a Standard Operating Procedure on the end-to-end early warning system for different hazards and feedback mechanisms and communication to address the vulnerabilities and risks that may occur in high risk areas or affected locality;

**NOW THEREFORE**, I, **RODOLFO T. ALBANO III**, Governor of Isabela, by virtue of the powers vested in me by law, do hereby order the Adoption of the Standard Operating Procedures on the end-to-end early warning system and feedbacking mechanisms and communication to residence in high risk areas in the province of Isabela.

**Further**, existing and operational multi-hazard early warning system crafted by PDRRMC, linked to disaster risk reduction which provides accurate and timely advice to the PDRRMC or local emergency response organizations and to the general public, through diverse mass media, particular radio, landline communications, and technologies for communication including social media within communities in the province is also hereby adopted and made an integral part hereof;

**Furthermore**, the Provincial Disaster Risk Reduction and Management Council (PDRRMC) shall strictly implement the Standard Operating Procedures on the end-to-end early warning system and feedbacking mechanisms and communication to residence in high risk areas in tight coordination with all authorities, Local Government Units and entities concerned for the successful implementation of this order.

All orders and issuances inconsistent with the provisions of this order are hereby repealed or modified accordingly.

In the event that any section, paragraph, sentence, clause, or word of this order is declared invalid for any reason, other provisions thereof shall not be affected thereby.

This order shall take effect immediately and let copies hereof be provided to all concerned for their information, reference, and guidance.
