**EXECUTIVE ORDER NO. 37**

### **ORGANIZING THE SUB-TECHNICAL WORKING GROUP TO CRAFT THE LOCAL ANTI-DRUG PLAN OF ACTION (LADPA) OF THE PROVINCE OF ISABELA**

**WHEREAS**, it is the policy of the State to safeguard the integrity of its territory and the well-being of its citizenry, and to provide effective mechanisms or measures to ensure public safety and law and order;

**WHEREAS**, the state shall promote the active and unified involvement of the local government units, communities, and civil society organizations to effectively prevent the proliferation of prohibited drugs;

**WHEREAS**, the state shall establish a mechanism and adequate administrative structural framework to ensure effective implementation of the anti-drug policies and programs;

**WHEREAS**, in accordance with DILG Memorandum Circular No. 2022-118, there is a need to create a Sub-Technical Working Group (Sub-TWG) to be in charge of crafting the Local Anti-Drug Plan of Action (LADPA) special sub-focused area of illegal drugs as inclusion in the POPS Plan.

**NOW THEREFORE, I, RODOLFO T. ALBANO III**, Governor of the Province of Isabela, by virtue of the powers vested in me by law, do hereby decree the following:

**Section 1: Creation.** There is hereby created the Sub-Technical Working Group (Sub-TWG) that will be tasked to prepare and craft the Local Anti-Drug Plan of Action of the Province of Isabela or LADPA;

**Section 3. Function.** The Sub-TWG LADPA shall have the following functions:

1. Lead in the formulation of Local Anti-Drug Plan of Action (LADPA);
2. Conduct data gathering and stakeholder consultations as needed and analyze data gathered;
3. Coordinate with communities or barangays for data-gathering and action planning for the implementation of LADPA;
4. Coordinate with POC Sub – Committee Heads relative to the recommended PPSAs for inclusion in the LADPA;
5. In coordination with POC Chair, Secretariat Head and LCEs, and TWG-POPS Plan for discussion, inclusion, approval, and appropriate action.
6. Present data to the POC for prioritization issues and development of strategies;
7. Draft and finalize LADPA; and
8. Perform such other tasks as may be directed by the council.

**Section 4. Repealing Clause.** All issuances, circulars, memoranda, rules, regulations, and their other issuances or parts thereof that are inconsistent herewith are hereby repealed, modified, or amended accordingly;

**Section 5. Effectivity.** This Executive Order shall take effect immediately.
