### **EXECUTIVE ORDER NO. 43** Series of 2022

#### **DESIGNATING A PROVINCIAL ECONOMIC DEVELOPMENT AND INVESTMENT PROMOTIONS OFFICER (PEDIPO) AND MEMBERS OF ITS TECHNICAL SUPPORT STAFF**

**WHEREAS**, DILG Memorandum Circular 2010-113 dated October 13, 2010, encourages Provincial Governors and City Mayors to designate a Local Economic and Investment Promotions Officer (LEIPO) as an economic partner in attracting more investment to enhance local economic activities;

**WHEREAS**, the roles of LEIPO are expanded in the administration of President Rodrigo Duterte on which the government draws its efforts to increase competitiveness and ease of doing business that will enable businesses to thrive in the country;

**WHEREAS**, in keeping with the President's thrusts to build a strong and resilient economy, the Department of the Interior and Local Government (DILG) continues to enhance the capabilities of LGUs as they play an active role in attracting investments to improve local economic development;

**WHEREAS**, DILG Memorandum Circular 2020-167 enjoins all local government units to designate a Local Economic Development and Investment Promotions Officer (LEDIPO) and establish its corresponding office/unit to facilitate and coordinate local economic development and investment promotion advocacies of the LGU;

**WHEREAS**, by virtue of Ordinance No. 2022-39-01, the Provincial Economic Development and Investment Promotions Unit (PEDIPU) in the Provincial Government of Isabela was created to facilitate/take charge of local economic development and investment promotion activities in the province;

**WHEREAS**, the designation of LEDIPO and its technical support staff is deemed necessary to encourage more investments and competitiveness in the locality to sustain economic development;

**NOW THEREFORE, I, RODOLFO T. ALBANO III**, Governor of Isabela, by virtue of the powers vested in me by law, do hereby order the designation of a Provincial Economic Development and Investment Promotions Officer (PEDIPO) and the members of its support staff;

**Section 1. Composition.** The PEDIP Unit shall be composed of a designated PEDIP Officer and three (3) technical support staff:

**Section 2. Functions and Responsibilities.** The PEDIP Officer shall be the focal person whose function is to facilitate the preparation, coordination, and execution of local economic development and investment promotion policies, programs, projects, and activities of the provincial government.

**Section 3. Funding.** The funding requirements shall be sourced from funds allocated to the Office of the Governor, subject to the usual budget, accounting, and auditing rules and regulations.

**Section 4. Separability Clause.** Should any provision of this Order be declared invalid or unconstitutional, the other provisions unaffected thereby shall remain valid and subsisting.

**Section 5. Repealing Clause.** All issuances, orders, rules, and regulations, or parts thereof that are inconsistent with any provision of this Order are hereby repealed or modified accordingly.

**Section 6. Effectivity.** This Executive Order shall take effect immediately.
