EXECUTIVE ORDER NO. 02 - 2022

**ORGANIZING THE PROVINCIAL LOCAL DISASTER RISK REDUCTION  
MANAGEMENT PLAN (LDRRMP) CORE GROUP AND TECHNICAL WORKING  
GROUP (TWG) OF THE PROVINCIAL GOVERNMENT OF ISABELA**

WHEREAS, Republic Act No. 10121 otherwise known as "**AN ACT STRENGTHENING THE PHILIPPINE DISASTER RISK REDUCTION AND MANAGEMENT SYSTEM, PROVIDING FOR THE NATIONAL DISASTER AND MANAGEMENT FRAMEWORK AND INSTITUTIONALIZING THE NATIONAL DISASTER RISK REDUCTION AND MANAGEMENT PLAN, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES**", provides for the organization at the local governance level of the *Provincial Disaster Risk Reduction and Management Council (PDRRMC)*;

WHEREAS, Section 2 (e) of **RA 10121 (Disaster Risk Reduction and Management Act of 2010)** provides that the LGUs shall Develop, promote, and implement a comprehensive **National Disaster Risk Reduction and Management Plan (NDRRMP)** that aims to strengthen the capacity of the national government and the local government units (LGUs), together with partner stakeholders, to build the disaster resilience of communities, and' to institutionalize arrangements and measures for reducing disaster risks, including projected climate risks, and enhancing disaster preparedness and response capabilities at all levels;

WHEREAS, Section 12 (6) of RA 10121 (Disaster Risk Reduction and Management Act of 2010) provides that LGUs shall formulate and implement a comprehensive and integrated LDRRMP in accordance with the national, regional and provincial framework, and policies on disaster risk reduction in close coordination with the Local Development Councils (LDCs);

WHEREAS, there is a need to create a **Core Team and the Technical Working Group (TWG)** who will work for the successful formulation/enhancement of the **Local Disaster Risk Reduction Management Plan (LDRRMP)** of the Province of Isabela;

NOW THEREFORE, I **RODOLFO T. ALBANO III**, Governor of the Province of Isabela, by virtue of the powers vested in me, hereby decree the organization of the **LDRRMP Core and Technical Working Group (TWG)**, to wit;
