EXECUTIVE ORDER NO. 04 - 2022

RECONSTITUTING THE TECHNICAL WORKING GROUP (TWG) IN-CHARGE OF THE PARTICIPATION OF THE PROVINCIAL GOVERNMENT OF ISABELA IN THE ANNUAL DILG SEARCH FOR RECIPIENTS OF THE SEAL OF GOOD LOCAL GOVERNANCE (SGLG)

Whereas, it is the policy of the State to encourage and promote good governance, and transparency and accountability in all levels of government;

Whereas, from 2010 to 2018, the Department of the Interior and Local Government implemented an incentive system that promoted transparency and accountability in local governance, awarding to local government units (LGUs) the then *Seal of Good Housekeeping*, then later the *Seal of Good Local Governance (SGLG)* for demonstrated good governance in the 7 key Assessment Areas of *Financial Housekeeping, Disaster Preparedness, Social Protection, Business-Friendliness and Competitiveness, Peace and Order, Environmental Management, and Culture and Tourism*;

Whereas, in 2019, Congress enacted Republic Act 11292, *An Act Establishing and Institutionalizing the Seal of Good Local Governance for Local Government Units, and Allocating for the Purpose, the Seal of Good Local Governance Fund*;

Whereas, RA 11292 provides that in lieu of the previously identified 7 key Assessment Areas, LGUs shall now be evaluated based on **Ten (10) Assessment Areas** in the Criteria, namely: **1) Good Fiscal Administration or Financial Sustainability; 2) Disaster Preparedness; 3) Social Protection and Sensitivity Program; 4) Health Compliance and Responsiveness; 5) Programs for Sustainable Education; 6) Business Friendliness & Competitiveness; 7) Safety, Peace & Order; 8) Environment Management; 9) Tourism, Heritage Development, Culture and Arts, and; 10) Youth Development**;

Whereas, the Provincial Government of Isabela (PGI) first organized its SGLG-Technical Working Group (SGLG-TWG) in 2016, in compliance with Executive Order No. 02-2016 to take the lead in preparing the Provincial Government for the DILG Evaluation, and ensure proper and tight coordination among offices and departments relative to SGLG requirements and the responsiveness of all PGI data and mechanisms thereto;

Whereas, with the separation from service and/or transfer of some of the members of the SGLG-TWG, there is a need to reconstitute the SGLG-TWG last reorganized in compliance with EO NO. 10-2018;

Now therefore, I, **RODOLFO T. ALBANO III**, Governor of Isabela, by virtue of the powers vested in me by law, do hereby decree the following:

Section 1. Reconstitution. The SGLG Technical Working Group (TWG) is hereby reconstituted.

Section 2. Composition. The SGLG TWG shall be reconstituted, to wit:
