EXECUTIVE ORDER NO. 46
Series of 2022

REORGANIZING THE PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (PDRRMC)

WHEREAS, Republic Act No. 10121, or the Philippine Disaster Risk Reduction and Management Act of 2010, requires the organization of a Provincial Disaster Risk Reduction and Management Council (the "PDRRMC", for brevity) in all provinces.

WHEREAS, from the time it was first organized by virtue of an executive order by then Provincial Governor Faustino G. Dy III, the PDRRMC of the province has been exemplary and emulated yet unmatched by other DRRM councils in terms of the performance of its mandate, so much so that it has been elevated to the *Gawad Kalasag* Hall of Fame.

WHEREAS, the PDRRMC was last reorganized on August 1, 2022 by virtue of Executive Order No. 29- A Series of 2022 issued by the undersigned.

WHEREAS, seats in the PDRRMC have been rendered vacant due to various causes including the promotion, transfer, or retirement of designated members, thus there is a need to reconstitute the same for the continuous and effective implementation of disaster risk reduction and management programs of the provincial government.

NOW, THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by the powers vested in me by law, do hereby reconstitute the Provincial Disaster Risk Reduction and Management Council as follows:

All orders, circulars, memoranda, rules and regulations, as well as other issuances or parts thereof inconsistent herewith are deemed repealed, modified, or amended accordingly.
