EXECUTIVE ORDER NO. <u>02</u> Series of 2023

RECONSTITUTING THE PROVINCIAL BIDS AND AWARDS COMMITTEE FOR GOODS AND SERVICES AND PROVINCIAL BAC FOR INFRASTRUCTURE PROJECTS

WHEREAS, Republic Act 9184, otherwise known as "The Government Procurement Reform Act" provides for the creation of the Provincial Bids and Awards Committee (PBAC) and its composition;

WHEREAS, Section 11.1.2 of RA 9184 provides that a separate BAC may be created as deemed by the Head of a Procuring Entity (HoPE) to expedite the procurement process for practical intents and purposes, and BACS may be organized by nature of procurement;

WHEREAS, to further professionalize and harmonize procurement procedures and standards, the Provincial Government of Isabela established by Executive Order of the Governor, one BAC for Goods and Services and another BAC for Infrastructure projects, both of which have been mandated to be primarily responsible for the conduct of the prequalification of contractors, bidding, evaluation of bids, and the recommendation of awards concerning local procurement;

WHEREAS, the separation, transfer and/or promotion from office of the members of the BAC for the period July 2019 thru December 2022, have resulted in vacancies in its membership;

WHEREAS, there is a need to reconstitute and reorganize the committees for the continuing effective implementation of the different BAC activities and programs;

NOW, THEREFORE, I, RODOLFO T. ALBANO III, Governor of Isabela, by virtue of the powers vested in me by Law, do hereby reconstitute the Provincial Bids and Awards Committee for Goods and Provincial BAC for Infrastructure and Services as follows:
