EXECUTIVE ORDER NO. <u>09</u> Series of 2023

REORGANIZING THE PROVINCIAL LOCAL CLIMATE CHANGE ACTION PLAN (LCCAP) CORE GROUP AND TECHNICAL WORKING GROUP (TWG) OF THE PROVINCIAL GOVERNMENT OF ISABELA

WHEREAS, it is the policy of the State to afford full protection and the advancement of the right of the people to a healthful ecology in accord with the rhythm and harmony of nature;

WHEREAS, Section 14 of the Republic Act 9729 also known as the Climate Change Act of 2009, the Local Government Units (LGUs) shall be the frontline agencies in the formulation, planning and implementation of the Climate Change (CC) action plans consistent with the provision of the Local Government Code of 1991, the framework and the National Climate Change Action Plan;

WHEREAS, Section 11 (2) of RA 10121(Disaster Risk Reduction and Management Act of 2010), provides that the LGUs shall ensure the integration or mainstreaming of disaster risk reduction and climate change adaptation into local development plans, programs and budget as a strategy in sustainable development and poverty reduction;

WHEREAS, there is a need to reorganize the Core Team and the Technical Working Group who will closely and collaboratively wok for the successful formulation/enhancement of the Local Climate Change Action Plan (LCCAP) of the Province of Isabela;

NOW, THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by virtue of the authority vested in me by law, do hereby reorganize the LCCAP Core and Technical Working Group, to wit:
