REORGANIZING THE PROVINCIAL CORE PLANNING TEAM (PCPT) ON THE PREPARATION OF PROVINCIAL COMMODITY INVESTMENT PLAN ADOPTING THE PRDP IPLAN ENHANCED OPERATIONS MANUAL

Whereas, The Department of Agriculture's Philippine Rural Development Project (DA PRDP) through the I-PLAN Component had ENHANCED THE OPERATIONS MANUAL (IPLAN-EOM) and was issued with No Objection Letter (NOL) by World Bank on December 20, 2022;

Whereas, the IPLAN –EOM primarily to enhance the planning process, as experiences in the past have gained, to incorporate risks and resiliency criteria in the formulation of the Provincial Commodity Investment Plans (PCIPs) and to address the evolving needs in the agriculture and fishery sector.

Whereas, the present PCIP 2020 – 2022 of the Province of Isabela has adopted the following commodities; 1. Dairy 2. Mungbean 3. Tilapia 4. Aromatic & Pigmented Rice 5. Pineapple 6. White Corn 7. Beef Cattle 8. Mango & 9. Banana;

Whereas, to be able to be responsive to the requirement and conform with the project design of DA-PRDP I-PLAN, the PCPT shall be formed for better collaboration with the commodity stakeholders in identifying potential intervention through actual, step-wise updating of the current PCIP;

Now therefore, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela by virtue of the powers vested in me by law, do hereby organize the Provincial Core Planning Team (PCPT) and order the following;

SECTION 1. Composition. The Provincial Core Planning Team (PCPT) shall compose of the following:

The above PCPT members shall designate their representative to compose the Technical Working Group (TWG) to ensure a stable and active participation of their respective offices.

SECTION 2. DUTIES AND FUCTIONS: The Team has the following duties and functions:

1. Assist the DA-RFO2 PMED/IPLAN Component in the conduct of commodity Value Chain Analyses (VCAs) that involve the province;
2. Rationalize the interventions that came out of the VCAs at the national and regional levels in relation to the overall development framework of the province;
3. Shall prepare, enhance and update a more climate-smart/ resilient Provincial Commodity Investment Plan (PCIP) adopting the Enhanced Operations Manual by integrating the Climate Resilient Vulnerability Assessment (CVRA) as a tool.
4. Finalized the PCIP with the assistance from the DA-RFO2 PMED/IPLAN Component considering the comments and suggestions gathered during the stakeholders' consultation;
5. Present the final PCIP to the Development Council (PDC) for deliberation and approval & for endorsement of the Governor to the Sangguniang Panlalawigan (SP) through the Vice Governor for corresponding appropriation of PPAs to be funded and for implementation according to the proposed timeline.

SECTION 3. OPERATIONS AND MANAGEMENT: For its operation and management as deemed necessary to carry out smooth implementation of the project, the PCPT shall have office together with the PPMIU, equipment and support vehicle. Likewise, funds for its office operational requirements shall be inclusive with the PRDP allocations annually.

SECTION 4. EFFECTIVITY: This Executive Order shall take effect immediately and shall continue until termination of the PRDP or until amended or revoked.
