EXECUTIVE ORDER NO. 25 Series of 2023

AN ORDER ORGANIZING THE PROVINCIAL PERFORMANCE ASSESSMENT TEAM (PPAT) IN THE PROVINCE OF ISABELA FOR THE CY 2023 IMPLEMENTATION OF THE SEAL OF GOOD LOCAL GOVERNANCE FOR BARANGAY (SGLGB)

WHEREAS, Section 5, Article II of the 1987 Constitution of the Republic of the Philippines declares that the maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy;

WHEREAS, Section 17 (b) (1) of Republic Act (RA) No. 7160 otherwise known as the Local Government Code of 1991, declares the provision of the minimum basic services and facilities in the barangay;

WHEREAS, Section 3 (h) and 3 (m), and Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code (LGC) of 1991, provide that there shall be a continuing mechanism to enhance local autonomy not only by legislative enabling acts but also by administrative and organizational reforms, that the national government shall ensure that decentralization contributes to the continuing improvement of the performance of local government units (LGUs) and the quality of community life, that each LGU shall exercise its powers essential to the promotion of the general welfare;;

WHEREAS, Section 1 of Executive Order No. 138 entitled: Full Devolution of Certain Functions of the Executive Branch to Local Governments, Creation of a Committee on Devolution, and for Other Purposes states that National Government (NG) is fully committed to the policy of decentralization enshrined in the Constitution and relevant laws which are aimed at 1) developing capabilities of local governments to deliver basic social services and critical facilities to their constituents, increase productivity and employment, and promote local and economic growth; and, 2) ensuring accountability, competence, professionalism and transparency of local leaders through the development of institutional systems that uphold good governance and strengthen their capacities for managing public resources;

WHEREAS, per DILG Memorandum Circular (MC) No. 2023-103 dated July 28, 2023 re 2023 Seal of Good Local Governance for Barangay, the DILG – National Barangay Operations Office (NBOO) shall roll-out the SGLGB for purposes of assessing the performance of the barangays, covering 2022 as the year under review;

WHEREAS, per DILG MC No. 2023-103, all local chief executives of provinces, cities and municipalities shall issue an Executive Order organizing the 2023 SGLGB Performance Assessment Team in their respective jurisdictions.

NOW THEREFORE, I, **RODOLFO T. ALBANO, III**, Governor, Province of Isabela, by virtue of the authority vested in me by law, do hereby order the organization of the Provincial Performance Assessment Team for the CY 2023 implementation of the Seal of Good Local Governance for Barangay (SGLGB), as follows:

Section 1. Composition – The PPAT of Isabela shall be composed of the following:

NOLASCO President – Isabela Provincial Employees Association

Section 2. Roles and Responsibilities of the PPAT - The PPAT shall perform the following roles and responsibilities:

1. Through the Technical Working Group (TWG), validate the data of barangays based on the assessment of Municipal SGLGB Assessor to ensure its correctness;
2. Approve and sign the Provincial Consolidated Performance Assessment Form (PCPAF, SGLGB Form 6); and
3. Ensure the completion of the provincial validation within the scheduled timeframe.

Section 3. The PPAT Secretariat – The Provincial Planning and Development Office shall serve as Secretariat of the PPAT and shall perform the following:

1. Present to the PPAT, during the validation meeting, all the submitted Component CC/M CPAF (SGLGB Form 4) together with the accomplished DCF (SGLGB Form 2) and MOVs;
2. Facilitate the accomplishment and signing of the PCPAF (SGLGB Form 6); and
3. Submitted the signed PCPAF to the RPAT.

Section 4. The PPAT Technical Working Group (TWG) – The PPAT TWG shall be composed of representatives from the DILG Provincial Office, Provincial Planning and Development Office, Liga ng mga Barangay, Panlalawigang Pederasyon ng Sangguniang Kabataan, and the Civil Society. They shall conduct the validation of data through review of submitted MOVs.

Section 5. Effectivity –This Order shall take effect immediately.
