### AN ORDER REORGANIZING THE EXPANDED PROVINCIAL LOCAL FINANCE COMMITTEE

**WHEREAS**, Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provided for the creation of the Local Finance Committee in every local government unit;

**WHEREAS**, Section 316 of said Code specifically enumerated the composition of the Local Finance Committee (LFC) such as: the Local Planning and Development Coordinator, the Local Budget Officer and the Local Treasurer;

**WHEREAS**, the Local Finance Committee consults with different offices for their technical and legal opinions, advice and recommendations for the effective execution of the committee's functions;

**WHEREAS**, the Local Chief Executive is not precluded by law to designate other members of the Provincial Committees, Boards and Councils who could facilitate effective and efficient execution of their functions;

**WHEREAS**, under Executive No. 18 Series of 2022 duly signed by Governor Rodolfo T. Albano III on 01 August 2022, the composition of the Local Finance Committee was expanded to include the Provincial Accounting and Provincial General Services Officer, Provincial Internal Audit and Control Officer (PIACO), Head Executive Assistant (HEA), and the Provincial Administrator (PA);

**WHEREAS**, the separation, transfer and/or promotion from office of the members have resulted in vacancies in the membership of the Committee;

**NOW THEREFORE**, I, **RODOLFO T. ALBANO III**, Governor of Isabela, by virtue of the powers vested in me by law, do hereby decree the following:

**Section 1. Reorganization.** The Expanded Provincial Local Finance Committee shall be reorganized as follows:

**Section 2. Fund Support.** The Expanded Provincial LFC shall be provided with the funding support to be taken from any available source deemed appropriate.

**Section 3. Repealing Clause.** All orders and issuances inconsistent with the provisions of this order are hereby repealed or modified accordingly.

**Section 4. Separability Clause.** In the event that any section, paragraph, sentence, clause, or word of this order is declared invalid for any reason, other provisions thereof shall not be affected thereby.

**Section 5. Effectivity.** This order shall take effect immediately and let copies hereof be provided to all concerned for their information, reference, and guidance.
