### EXECUTIVE ORDER NO. 05 Series of 2024

#### REORGANIZING THE ISABELA PROVINCIAL TOURISM COUNCIL

**WHEREAS**, Republic Act No. 9593, otherwise known as the "Tourism Act of 2009" declares tourism as an indispensable element of the national economy and an industry of national interest and importance, which must be harnessed as an engine of socio-economic growth and cultural affirmation to generate investment, foreign exchange and employment, and to continue to mold and enhanced sense of national pride of all Filipinos;

**WHEREAS**, Department of the Interior and Local Government Memorandum Circular No. 95-162 date 03 October 1995 enjoins all Local Government Units to create Tourism Councils composed of government and private sector representatives to formulate programs and recommendations to develop local tourism facilities and attractions, assist in the regulation and supervision of tourism-oriented establishments thereby ensuring wholesome and clean tourism activities, assist in monitoring the implementation of the Local Government Code on the matter of licensing of tourism establishments in the locality to ascertain safe and enjoyable stay of travelers;

**WHEREAS**, the Provincial Government of Isabela shall adopt the principle of sustainable tourism development in the formulation of its local tourism development plans to give due regard to the conservation of natural resources and preservation of cultural heritage while allowing opportunity for local communities to achieve a better life;

**WHEREAS**, the separation, transfer and/or promotion from office of the members of the Isabela Tourism Council, have resulted in vacancies in the membership of the Council;

**NOW THEREFORE, I, RODOLFO T. ALBANO III**, Governor of the Province of Isabela, by virtue of the powers vested in me by law, hereby decree the following:

**SECTION 1. REORGANIZATION.** THE ISABELA PROVINCIAL TOURISM COUNCIL (IPTC) is hereby reorganized.

**SECTION 2. COMPOSITION.** The IPTC shall be reorganized, to wit:

**SECTION 3. DUTIES AND FUNCTIONS.** The council shall have the following duties and functions:

- a. Formulate programs to develop promotion of local tourism.
- b. Develop tourism facilities and infrastructure.
- c. Formulate and submit tourism development/ promotion proposals for local legislation, seek approval from the executive branch of the provincial government to provide fiscal and non-fiscal incentives that will strengthen private sector investments in tourism- related activities.
- d. Assist in the regulation and supervision of tourism-oriented establishments thereby ensuring wholesome and clean tourism activities.
- e. Coordinate every tourism programs and events in the province.
- f. Assist in monitoring the implementation of the Local Government Code particularly on the matter of licensing of tourism establishment in the province in order to ensure a safe and enjoyable stay of the tourists and travelers.

**SECTION 3. EFFECTIVITY.** This Executive Order shall take effect immediately.
