REORGANIZING THE PROVINCIAL LAND USE COMMITTEE (PLUC) OF THE PROVINCE OF ISABELA

WHEREAS, Republic Act 7160, provides for the creation of the Provincial Land Use Committee (PLUC) and its power to review the Comprehensive Land Use Plan (CLUP) of cities and municipalities to ensure their conformity with the Provincial Development and Physical Framework Plan (PDPFP), Provincial Development Investment Plan (PDIP) and the Provincial Disaster Risk Reduction and Management Plan of the province;

WHEREAS, Executive Order No. 72, 1993, in reviewing the Comprehensive Land Use Plan, the PLUC is mandated to consider primarily, the requirements for food production, human settlement, ecological balance, and industrial expansion before endorsing the same to the Sangguniang Panlalawigan for the final approval;

WHEREAS, the separation, transfer, and/or personnel movement in many of the member agencies and offices of the original members of the PLUC necessitates the need to reorganize the existing Provincial Land Use Committee of the province of Isabela;

WHEREAS, DILG Memorandum Circular 2016-102 requires the updating of Comprehensive Development Plans (CDPs) and Comprehensive Land Use Plans (CLUPs) of all LGUs, as well as Provincial Development & Physical Framework Plans (PDPFP);

WHEREAS, DHSUD Memorandum Circular 2021-005 requires revision and enhancement in the review and approval processes of Comprehensive Land Use Plans (CLUPs) and Zoning Ordinances (ZOs), requiring the integration of the parameters for the review of CLUPs as guide/instructions corresponding to the updating, enhancement, and reorganization, if necessary, of all special bodies created by LGUs, to ensure harmonization with the national level, enhancement in planning and adaptation and mitigation (DRRM-CCAM), culture and heritage and environmental protection and other concerns such as conflict sensitivity and those of the marginalized sectors.

NOW THEREFORE, I RODOLFO T. ALBANO III, Provincial Governor of the Province of Isabela, by virtue of the authority vested in me by law, do hereby order to reorganize the Provincial Land Use Committee (PLUC) of the Province of Isabela into the following composition:

FURTHER, it is hereby ordered that the PLUC shall continue to discharge the following functions and responsibilities:

1. The DHSUD-RO shall receive the CLUPs and ZO of the component cities and municipalities documents and checks for completeness. Upon checking and accomplishing the required documents the CLUPs and ZOs shall be endorsed to Sangguniang Panlalawigan.
2. The Sangguniang Panlalawigan, through the PLUC Secretariat shall receive/check/verify the CLUPs of the component cities and municipalities documents and shall be endorsed to PLUC for review.
3. Upon integrating all the comments and/or recommendations, the CLUPs and ZO shall be endorsed to LGU for adoption and enactment.
4. The LGUs shall submit its enhance CLUPs and ZOs to the Sangguniang Panlalawigan, through the PLUC, for cursory review and approval.
5. Specifically, it shall review plans to:
 - a. Ensure that land use plans of component cities and municipalities are consistent with the Provincial Physical Framework Plan (PPFP) and Provincial Development Plan, provincial comprehensive land use plans, and national policies, standards, and guidelines;
 - b. Recommend solution to settle disputes among component units over the alternative uses of land resources;
 - c. Ensure mainstreaming of disaster risk reduction and management and climate change adaption (DRRM-CCA) and other thematic and sectoral concerns into the Comprehensive Land Use Plan (CLUP) of component cities and municipalities;
 - d. Promote the Community-based program for sustainable development; and
 - e. Ensure such plans are supportive of the objectives set forth in the Urban Development Act of 1992 (UDHA), Agriculture Fisheries and Modernization Act of 1997 (AFMA), National integrated Area System (NIPAS Act), Compliance to the MC. 54 (reclassification of Agricultural Land to Non-Agricultural Lands), and other related laws.

The committee is required to meet as often as necessary in order to effect the Review of all Comprehensive Land Use Plans submitted to the Sangguniang Panlalawigan for consideration and/or approval, to be presided over by the Provincial Planning & Development Coordinator.

The Provincial Planning & Development Coordinator shall issue the required notice of meeting to all the PLUC members at least two (2) weeks before the date of the meeting as well as the agenda hereof.

The committee may also create a Secretariat and an inter-agency Technical Committee as may be warranted by circumstances that would assist in the conduct and discharge of its functions and responsibilities. The secretariat shall transmit copies (digital or printed) of Parameters for the Review of CLUPs (Annex 4, MC. 2021-005) as the guide for PLUC members to generate their respective comments and recommendations.

All orders, circulars, memoranda, rules, regulations, and their other issuances or parts thereof that are inconsistent herewith are hereby repealed, modified, or amended accordingly;
