**EXECUTIVE ORDER NO. 12**

### **AN ORDER REORGANIZING THE PLANNING CORE TEAM AND ITS TECHNICAL WORKING GROUP FOR THE UPDATING OF THE PROVINCIAL DEVELOPMENT AND PHYSICAL FRAMEWORK PLAN (PDPFP) OF THE PROVINCE OF ISABELA**

**WHEREAS**, Section 20(c) of the Local Government Code mandates local government units to prepare their respective comprehensive land use plans which shall be the primary and dominant bases for the future use of land resources;

**WHEREAS**, the Provincial Development and Physical Framework Plan (PDPFP) serves as the blueprint for the development and physical transformation of the Province of Isabela, providing a vision, goals, strategies, and a spatial development framework that guides land use and infrastructure development;

**WHEREAS**, the existing PDPFP 2018-2023 of the Province of Isabela is due for updating for another planning period in order to ensure its relevance and effectiveness in responding to the current state of the province's economy, social conditions, natural resources, and physical environment;

**WHEREAS**, the updating of the PDPFP requires a concerted effort from various stakeholders and technical experts to ensure its relevance, comprehensiveness, and effectiveness; hence, the need to create a Planning Core Team and a Technical Working Group to facilitate the development of a comprehensive and participatory plan;

**WHEREAS**, the separation, transfer and/or promotion from office of the members of the Planning Core Team and TWG for the period January 2023 thru December 2023, have resulted in vacancies in its membership;

**NOW, THEREFORE, I, RODOLFO T. ALBANO III**, Governor of the Province of Isabela, by virtue of the powers vested in me by law, do hereby order the creation of the Planning Core Team and its Technical Working Group for the updating of the PDPFP of the Province of Isabela;

**SECTION 1. CREATION OF THE PLANNING CORE TEAM.** The Planning Core Team shall be composed of the following members:

**SECTION 2. CREATION OF THE TECHNICAL WORKING GROUP.** There shall be a technical working group for each of the five development sectors of the development plan, namely: (1) Social Development, (2) Economic Development, (3) Physical/Land Use Development, (4) Environmental Management, and (5) Institutional Management. **SECTION 3. FUNCTIONS, DUTIES, AND RESPONSIBILITIES.** The Planning Core Team and its Technical Working Group shall have the following function, duties, and responsibilities:

**PLANNING CORE TEAM.** The Planning Core Team shall have the following functions:

- a. Responsible for all planning activities in the updating of the PDPFP;
- b. Ensure the consistency of the updated PDPFP with national and regional development plans;
- c. Ensure the participation and consultation of relevant stakeholders in the updating process;
- d. Prepare the final draft of the updated PDPFP for review and approval by the Provincial Development Council;
- e. Facilitate the presentation of the draft updated PDPFP to the DHSUD/RLUC and endorsement to the Sangguniang Panlalawigan; and
- f. Perform such other functions as may be necessary to carry out the objectives of this Executive Order.

**TECHNICAL WORKING GROUP.** The Technical Working Group shall have the following functions:

- a. Prepare the necessary data, information, and reports for the updating of the PDPFP;
- b. Conduct research and data analysis on the various aspects of the PDPFP, such as the natural resources, physical environment, socioeconomic conditions, and infrastructure;
- c. Identify and prioritize development goals, strategies, and programs/projects for inclusion in the PDPFP; and
- d. Perform such other functions as may be necessary to carry out the objectives of this Executive Order.

The Provincial Planning and Development Office shall provide technical and administrative support in all activities in the updating of the PDPFP.

**SECTION 4. REPEALING CLAUSE.** Previous issuances or any portion thereof, which are inconsistent with the provision of this Executive Order are hereby amended, modified, suspended, or repealed accordingly.

**SECTION 5. SEPARABILITY CLAUSE.** If any section or provision of this Executive Order is declared void, ineffective, or invalid, other provisions not affected thereof shall remain in full force and effect.

**SECTION 6. EFFECTIVITY.** This Executive Order shall take effect immediately upon the date hereof and shall remain in effect until rescinded, repealed, or amended.
