**EXECUTIVE ORDER NO. 20**  
Series of 2024

### **REORGANIZING THE PROVINCIAL AUDIT TEAM (PAT) TO CONDUCT PERFORMANCE AUDIT ON ALL MUNICIPAL AND COMPONENT CITY PEACE AND ORDER COUNCILS FOR THE YEAR 2024**

**WHEREAS**, the constitution declares that maintenance of peace and order, the protection of life, liberty, and property and the promotion of the general welfare are essential for the enjoyment by all the people under the blessings of democracy;

**WHEREAS**, pursuant to Section 116 of RA 7160 and Section 1.b. and Section 3 of EO no. 773 series of 2009 designating the governor of the province as the Chairman of the Provincial Peace and Order Council and to exercise duties and functions necessary, appropriate, or incidental for its efficient and effective discharge of responsibilities on matters affecting major issues and problems regarding peace and order, including insurgency;

**WHEREAS**, for sustained Security, Public Order and Safety, collaboration among LGUs, law enforcement and the local community is encouraged to effectively maintain peace and order, through the Peace and Order Councils (POCs) stronger cooperation between the LGU, law enforcement and community is ascertained, and serves as a platform to fight criminality, illegal drugs, insurgency and violent extremism;

**WHEREAS**, Peace and Order Councils shall institute a holistic approach in addressing criminality and illegal drugs and empowering communities by increasing their capacity to address conflict, reduce their vulnerabilities, strengthening government peace and development institutions and mechanisms to increase their responsiveness to peace and conflict;

**WHEREAS**, there is a need to solidify and assert harmony and support among the members of POC to effectively implement peace and order and public safety activities that promotes volunteerism, intensified advocacy and preventive education;

**WHEREAS**, there is a need to profile and measure the efficacy of implementation of programs, projects, activities and over- all performance of all local Peace and Order Councils in the province;

**NOW THEREFORE, I, RODOLFO T. ALBANO III**, Governor of the Province of Isabela, by virtue of the powers vested in me by law, do hereby decree the following:

**Section 1. REORGANIZATION.** The Provincial Audit Team (PAT) of the province of Isabela is hereby reorganized as follows:

**Section 2. NATURE AND CHARACTER.** the Provincial Peace and Order Council (PPOC)- Provincial Audit Team (PAT) shall serve as the assessment mechanism to profile and review the performance of all municipal and component city peace and order councils in the province based from the criteria guided by these pillars: Organization, Meetings, Reports, Innovations Policies, Plans and Budget;

**Section 3. FUNDING.** Funding for the operations of the Provincial Audit Team shall be sourced from the POC Funds.

**Section 4. REPEALING CLAUSE.** All issuances, orders, rules and regulations, or parts thereof that are inconsistent with any provision of this Order are hereby repealed or modified accordingly.

**Section 5. EFFECTIVITY.** This Executive Order shall take effect immediately.
