### EXECUTIVE ORDER NO. 21 Series of 2024

#### REORGANIZING THE PROVINCIAL MASA MASID TASK FORCE TO ENSURE LGU COMPLIANCE WITH DILG MEMORANDUM CIRCULAR 2016-116 AND OTHER ISSUANCES RELATIVE TO THE PROVINCIAL ANTI-DRUG ABUSE PROGRAMS AND OTHER ACTIVITIES

**WHEREAS**, it is the policy of the State to safeguard the integrity of its territory and the well-being of its citizenry, and provide effective mechanisms or measures to ensure public safety and law and order;

**WHEREAS**, in pursuit of the National Government's policy to stamp out criminality, corruption, and illegal drugs, the Department of the Interior and Local Government issued Memorandum Circular No. 2016-116 to launch the MASA MASID (Mamamayang Ayaw sa Anomalya, Mamamayang Ayaw sa Iligal na Droga) Program, an initiative that engages community volunteers and faith-based organizations through the Ugnayang Barangay at Simbahan or UBAS, in advocating crime prevention, peace and order, security, and in enhancing transparency and accountability in the barangay;

**WHEREAS**, the MASA MASID Program shall focus on conducting information and education campaigns against corruption, criminality, and illegal drugs in communities, establishing reporting mechanisms, formulation community-based rehabilitation/intervention programs for the victims, and promoting the spirit of volunteerism to encourage people to become agents of positive change;

**WHEREAS**, Executive Order No. 02, series of 2017 was issued by the Governor, directing all local chief executives in the Province of Isabela to organize their respective Expanded Ugnayang Barangay at Simbahan (Expanded UBAS) Technical Working Group which will steer the implementation of the MASA MASID Program and organize, unify, and train MASA MASID Teams (MMTs) in the barangay level, as provided in the DILG MC 2016-116;

**WHEREAS**, it shall be the MASA MASID TEAMS that shall serve as the main implementing arm of the MASA MASID Program at the barangay level;

**WHEREAS**, the Provincial MASA MASID Task Force shall also ensure that the Programs, Projects, and Activities (PPAs) of the Provincial Anti-Drug Abuse Council (PADAC) are extended to the City and Municipal Anti-Drug Abuse Councils;

**WHEREAS**, the separation, transfer and/or promotion from office of the members of the MASA MASID Task Force;

**WHEREAS**, there is a need to reorganize the MASA MASID Task Force to ensure continuity in the body's plans and projects;

**NOW THEREFORE, I, RODOLFO T. ALBANO III**, Governor of the Province of Isabela, by virtue of the powers vested in me by law, do hereby decree the following:

**Section 1. RE-ORGANIZATION.** There is hereby reorganization of the Provincial MASA MASID TASK FORCE of the Province of Isabela.

**Section 2. NATURE AND CHARACTER.** The MASA MASID Task Force is a special unit under the Office of the Governor. It serves as the Governor's office in-charge of monitoring compliance by all local chief executives in Isabela with DILG Memorandum Circular 2016-116 and other issuances relative to the Provincial Anti-Drug Abuse programs and other activities.

**Section 3. COMPOSITION.** The MASA MASID Task Force shall be reorganized as follows:
