**AN ORDER REORGANIZING THE PROVINCIAL YOUTH
DEVELOPMENT COUNCIL (PYDC) OF THE PROVINCE OF ISABELA**

WHEREAS, Article II, Section 13 of the 1987 Constitution recognizes the vital role of the youth in nation building and shall promote and protect their physical, moral, intellectual, and social wellbeing;

WHEREAS, Chapter III, Section 23 of Republic Act No. 10742, otherwise known as the Sangguniang Kabataan Reform Act of 2015, mandates the creation of the Local Youth Development Council (LYDC) in every City, Municipal, and Provincial Local Government Unit;

WHEREAS, Section 24 (j) of the Implementing Rules and Regulations of RA 10742 mandates that “within forty-five (45) days after SK Elections, the Local Youth Development Office (LYDO)... shall notify all the presidents or authorized representatives of the registered youth organizations or youth-serving organizations in the locality, assemble them in a public venue, and by consensus or secret balloting, they shall choose at least eight (8) but not more than nineteen (19) representative [who] shall serve... in the LYDC”;

WHEREAS, Rule III, Section 25 of the Implementing Rules and Regulations of RA 10742 states that Local Government Units shall provide support to the operations of the Local Youth Development Council;

WHEREAS, Sangguniang Panlalawigan Ordinance No. 02 Series of 2016, otherwise known as the Isabela Youth Welfare and Development Code, as amended through Ordinance No. 2020-03-2 Series of 2020, declares it a policy of the provincial government to ensure the participation of the youth in decision-making process on the resolution of various issues concerning the youth through the strengthening of the Isabela Youth Development Council;

WHEREAS, the Provincial Government of Isabela, through the 6th Provincial Youth Summit, convened all registered youth and youth-serving organizations in a public venue and conducted the election of the new representatives to the Isabela Provincial Youth Development Council presided by the newly-elected SK Panlalawigan Pederasyon President;

WHEREAS, it is a priority agenda of the Provincial Government of Isabela to champion Youth Development and strengthen youth participation in all facets of local governance;

NOW THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by virtue of the powers vested in me by law, do hereby order the reorganization of the COUNCIL NAGKAKAISANG KABATAANG ISABELEÑO (NAGKAISA) – PROVINCIAL YOUTH DEVELOPMENT COUNCIL (PYDC) as follows:

SECTION 1. TERM. The members of the Council NAGKAISA – PYDC shall serve until the election of the succeeding Sangguniang Kabataan Officials.

SECTION 2. COMPOSITION. The Provincial Youth Development Council of the province of Isabela shall be reorganized as follows:

The convening and election of the members of the Provincial Youth Development Council has been consistent and in accordance with the Implementing Rules and Regulations of RA 10742, Rule III, Section 24, as supplemented by DILG Memorandum Circular 2018-124 dated August 8, 2018.

SECTION 3. DUTIES AND RESPONSIBILITIES. The Provincial Youth Development Council shall have the following duties and responsibilities:

1. Serve as the core of the advocacy on youth participation in nation-building and youth empowerment in the province of Isabela;

2. Finalize the three (3) year Provincial Youth Development Plan (PYDP) of the Province of Isabela;

The PYDP shall be initially drafted by the SK Panlalawigan Pederasyon and shall be finalized by the Provincial Youth Development Council. This shall be submitted to the Local Chief Executive for inclusion in the Local Development Plan and subsequently endorsed to the Sangguniang Panlalawigan for adoption and approval.

3. Monitor and evaluate the implementation of the Provincial Youth Development Plan;
4. Attend and participate in the quarterly meetings and all other meetings of the Council; and,
5. Perform such other functions as may be prescribed by law or order.

SECTION 4. All other issuances, orders, rules and regulations, or parts thereof that are inconsistent with any provision of this Order are hereby repealed or modified accordingly.

SECTION 5. This Executive Order shall take effect immediately.
