EXECUTIVE ORDER NO. 28-A

REORGANIZING THE PROVINCIAL SOLID WASTE MANAGEMENT BOARD (PSWMB) OF THE PROVINCE OF ISABELA

WHEREAS, it is the policy of the State, as embodied in Republic Act 9003 or the Ecological Solid Waste Management Act of 2000, to adopt a systematic, comprehensive and ecological solid waste management program that will ensure the protection of public health and environment;

WHEREAS, local government units shall be primarily responsible in implementing and enforcing the provisions of the Ecological Solid Waste Management Act of 2000, in coordination with the National Ecological Solid Waste Management Commission, other concerned agencies and sectors, as provided for under RA 9003;

WHEREAS, RA 7160 or the Local Government Code, empowers the Provincial Governor to carry out measures for the appropriate enforcement and execution of laws and ordinances;

WHEREAS, the Sangguniang Panlalawigan of Isabela passed Resolution No. 007 on September 04, 2001, authorizing the Provincial Government to create the Provincial Solid Waste Management Board (PSWMB) of the Province of Isabela;

WHEREAS, with the turnover in the elective positions, re- assignments and separation from service of representatives of some member-agencies, transfer, and/or promotion from office of personnel tasked to implement programs on solid waste management, there is a need to update the composition of the Provincial Solid Waste Management Board to ensure effective delivery of its functions through proper representation of the offices and organizations;

NOW THEREFORE, I, **RODOLFO T. ALBANO III**, Governor of Isabela, by virtue of the powers vested in me by law, do hereby reorganize the Provincial Solid Waste Management Board (PSWMB) as follows:

Section 2. Functions. The PSWMB shall have the following functions and responsibilities:

- a) Review and integrate the submitted solid waste management plans of the respective city and municipal solid waste management boards and develop a provincial solid waste management plan, ensuring that the plans complement each other, for submission to the Commission for approval.

The Provincial Plan shall reflect the general program of action and initiatives of the provincial government in implementing a solid waste management program that would support the various initiatives of its component cities and municipalities;

- b) Oversee the implementation of the Provincial Solid Waste Management Plan;
- c) Identify areas within Isabela that have common solid waste management problems and are appropriate units for planning local solid waste management services in accordance with Section 41 of RA 9003;
- d) Recommend measures and safeguards against pollution and for the preservation of the natural ecosystem;
- e) Allow measures to generate resources, funding, and implementation of projects and activities as specified and duly approved solid waste management plans;
- f) Allow for the clustering of local government units for the solution of common solid waste management problems;
- g) Develop incentive schemes as in integral component of the Provincial Solid Waste Management Plan;
- h) Coordinate the efforts of the component cities and municipalities in the implementation of the Provincial Solid Waste Management Plan;
- i) Convene joint meeting of the provincial, city and municipal solid waste management boards at least quarterly for purposes of integrating, synchronizing, monitoring, and evaluating the development and implementation of its provincial solid waste management plan;
- j) Review every two (2) years or as the need arises, the Provincial Solid Waste Management Plan to ensure its sustainability, viability, effectiveness, and relevance in relation to local and international developments in the field of solid waste management;
- k) Represent any of its component cities or municipalities in coordinating its resource and operational requirements with agencies of the national government;
- l) Provide the necessary logistical and operational support to its component cities and municipalities in accordance with subsection (f) of Section 17 of the Local Government Code;
- m) Perform all other functions and duties as may be necessary in and consistent to the implementation of RA 9003.

Section 3. The PSWMB Secretariat. As the technical arm of the Provincial Government in forest and environmental concerns, the Environment and Natural Resources Office (ENRO) shall serve as the Secretariat to the Board in all its undertaking, to ensure the smooth implementation of the provisions of RA 9003, in accordance with the Provincial Solid Waste Management Plan.

The PSWMB Secretariat shall assist the PSWMB in its capacity as the official Technical Working Group (TWG). It shall have the following duties and functions in the enforcement of RA 9003 in the province of Isabela:

1. Serve as technical arm of the PSWMB in the implementation of pertinent provisions of RA 9003 and its implementing rules and regulations;
2. Perform all other tasks as may be prescribed by the Board in the smooth implementation of RA 9003 in the province of Isabela.

Section 4. Budgetary Requirements. The funding requirements for the operations of the PSWMB shall be sourced from the Office of the Governor, subject to the usual budget, accounting, and auditing ruled and regulations.

Section 5. Repealing Clause. All issuance, orders, rules and regulations, or parts thereof that are inconsistent with any provision of the Order are hereby repealed or modified accordingly.

Section 6. Effectivity. This Executive Order shall take effect immediately.
