EXECUTIVE ORDER NO. 28

AN ORDER DIRECTING ALL OFFICES AND HOSPITALS UNDER THE PROVINCIAL GOVERNMENT OF ISABELA TO PRACTICE ECOLOGICAL SOLID WASTE MANAGEMENT/ WASTE SEGREGATION WITHIN THEIR RESPECTIVE AREAS

WHEREAS, it is the policy of the State, as embodied in Republic Act 9003 or the Ecological Solid Waste Management Act of 2000, to adopt a systematic, comprehensive, and ecological solid waste management program that will ensure the protection of public health and the environment;

WHEREAS, Pursuant to RA 9003, Local Government Units (LGUs) are primarily responsible in implementing and enforcing the law's provisions;

WHEREAS, Resolution No. 171 Series of 2017 was issued by the 9th Sangguniang Panlalawigan of Isabela adopting Solid Waste Management within Institutional Buildings of the Provincial Government of Isabela and for other purposes;

WHEREAS, the Isabela- Provincial Solid Waste Management Board (PSWB) had established the Provincial Ecology Center (PEC), consistent with the provisions of RA 9003 implementing the solid waste management systems within the provincial capitol premises and hospital compound;

WHEREAS, the Provincial Ecology Center endeavors to establish waste minimization strategy with emphasis on resource maximization through waste reduction, re-use, and recycling on solid waste generation with management techniques as well as technical and operation approaches in waste resources recovery;

WHEREAS, there is a need to accomplish the goals of a clean, healthy, and balanced ecology in the province starting with the departments, offices, and provincial government-operated hospitals to further strengthen its commitment towards the protection of public health and the integrity of the environment;

NOW THEREFORE, I, **RODOLFO T. ALBANO III**, Governor of Isabela, by virtue of the powers vested in me by law, do hereby issue AN ORDER DIRECTING ALL OFFICES AND HOSPITALS UNDER THE PROVINCIAL GOVERNMENT OF ISABELA TO PRACTICE ECOLOGICAL SOLID WASTE MANAGEMENT/ WASTE SEGREGATION WITHIN THEIR RESPECTIVE AREAS.

The Environment and Natural Resources Office is hereby tasked to implement and monitor the compliance of this Order and furnish monthly report regarding such implementation to the Office of the Governor.

Let copies hereof be furnished the Sangguniang Panlalawigan for the Body's subsequent adoption, and all offices and hospitals operated by the provincial government for their information and reference.

This Executive Order shall take effect immediately.
