EXECUTIVE ORDER NO. 35 Series of 2024

AMENDING EXECUTIVE ORDER NO. 3 SERIES OF 2024 TO INCLUDE TESDA- ISABELA AS MEMBER OF THE ISABELA PROVINCIAL SCHOOL BOARD

WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of 1991, provides for the establishment of Local School Board (LSB) in every province, city and municipality, a Provincial School Board;

WHEREAS, the Technical Education and Skills Development Authority (TESDA) expresses their intention to be a part of the Provincial School Board pursuant to the Joint Memorandum Circular with the Department of Education (DepEd) regarding the integration of Technical and Vocational Education Training (TVET) in all Senior High School tracks;

WHEREAS, embodied in a separate Joint Memorandum Circular issued by TESDA and DepEd is the establishment of an assessment and certification process for a quality- assured certification to ensure the employability of the Senior High School graduates in the local and global markets and to provide them entrepreneurial opportunities;

WHEREAS, there is a need to amend Executive Order No. 3 Series of 2024 "Reorganizing the Provincial School Board" issued by the undersigned in January 4, 2024 to further reconstitute the PSB for the continuing effective implementation of the education and youth development programs and initiatives of the DepEd, the TESDA, the educational institutions in the province and the provincial government;

NOW THEREFORE, I, **RODOLFO T. ALBANO III**, Governor of Isabela, by virtue of the powers vested in me by law, do hereby reconstitute the Provincial School board of the province of Isabela as follows:
