EXECUTIVE ORDER NO. 37 Series of 2024

RECONSTITUTING THE PROVINCIAL BIDS AND AWARDS COMMITTEE

WHEREAS, Republic Act 9184, otherwise known as “The Government Procurement Reform Act” provides for the creation of the Provincial Bids and Awards Committee (PBAC) and its composition;

WHEREAS, to further professionalize and harmonize procurement procedures and standards, the Governor issued an Executive Order establishing the PBAC which was mandated to be primarily responsible for the conduct of the prequalification of contractors, bidding, evaluation of bids, and the recommendation of awards concerning local procurement;

WHEREAS, the separation, re-assignment, transfer and/or promotion from office of the members of the BAC for the period January 2024 to July 2024, have resulted in vacancies in its membership and to further rationalize the operation of the BAC pursuant to the new development in procurement;

WHEREAS, there is a need to reconstitute and reorganize the committees for the continuing effective implementation of the different BAC activities and programs;

NOW, THEREFORE, I, **RODOLFO T. ALBANO III**, Governor of Isabela, by virtue of the powers vested in me by Law, do hereby reconstitute the Provincial Bids and Awards Committee as follows:
