ALBANO III, TO AFFIRM THE INTEREST OF AND TO UNDERTAKE NECESSARY ACTIONS FOR THE PROVINCE OF ISABELA TO AVAIL FINANCIAL ASSISTANCE TO THE INFRASTRUCTURE, ENTERPRISE DEVELOPMENT AND OTHER SUPPORT FROM THE PHILIPPINE RURAL DEVELOPMENT PROGRAM OF THE DEPARTMENT OF AGRICULTURE (PRDP-DA)

WHEREAS, Republic Act No. 8435, otherwise known as the Agriculture and Fisheries Modernization Act (AFMA) of 1997 sets out the Government's policies in the agriculture sector in attaining equitable distribution of opportunities, income and wealth, expanding productivity, and sustaining increase in production of goods and services thereby raising the quality of life of the people, especially the underprivileged;

WHEREAS, in furtherance of the welfare of the Province's local farmers and to promote the advancement of the agricultural sector, this Body determined that there is a need to communicate and reaffirm the interest of the Province in providing cooperation to and obtaining support from the PRDP-DA, especially in securing

assistance in the latter's Investments in Rural Enterprises and Agriculture and Fisheries Productivity (I-REAP), Intensified Building-Up of Infrastructure and Logistics for Development (I-BUILD), and other proposed stand-alone projects;

WHEREFORE, upon motion of HON. MARCO PAOLO A. MERIS, Chairman-Committee on Local Government, duly seconded and approved by all the members present in a session duly assembled, it was-

RESOLVED AS IT IS HEREBY RESOLVED, to reaffirm the interest of the Province of Isabela to participate in the Philippine Rural Development Program (PRDP) to finance the proposed subprojects I-REAP, I-BUILD, and other proposed stand-alone projects;

RESOLVED FURTHER, to authorize and empower the incumbent **Provincial Local Chief Executive, HON. RODOLFO T. ALBANO III,** for and in behalf of the Province of Isabela, to undertake the following:

- a. To apply, negotiate, enter into contract, execute, sign memoranda of agreement, implementation managements and other documents for subproject implementation with the Department of Agriculture (DA), proposed subprojects for I-REAP,I-BUILD, and other proposed stand-alone projects, including amendments, renewal and/or extension thereof under such terms and conditions as may be agreed upon by DA under the PRDP;
- b. To issue an Executive Order (EO) creating the Provincial Project Management and Implementation Unit (PPMIU);
- c. To authorize the Local Chief Executive to enter into a contract with the winning bidder for civil works, consultancy and procurement of goods/equipment and other agreements required to be undertaken;
- d. To undertake all acts necessary for the effective implementation of the proposed subproject.

RESOLVED FURTHERMORE, to authorize the Provincial Governor, **HON**. **RODOLFO T. ALBANO III**, for and in behalf of the Province of Isabela, to affirm and undertake the following commitments required by the PRDP-DA;

- a. To appropriate equity required of the subproject in accordance with the Implementing Management Agreement (IMA) signed by the PLGU and the DA;
- To appropriate and/or allocate additional funds necessary for the efficient and effective implementation including operational and maintenance costs of the completed subprojects;
- c. To provide office space, supplies and materials, equipment and vehicles for the efficient supervision and monitoring of the subproject/s;
