**A RESOLUTION CONFIRMING THE APPOINTMENT OF HON. GRETCHEN FLORES VALDEZ AS SECTORAL REPRESENTATIVE ON INDIGENOUS CULTURAL COMMUNITIES TO THE SANGGUNIANG PANLALAWIGAN, PROVINCE OF ISABELA**

**WHEREAS**, Republic Act 7160 otherwise known as the Local Government Code of 1991 explicitly provides under Article III. Section 467 that in addition to the composition of the regular members of the Sangguniang Panlalawigan, there shall be three (3) sectoral representatives each from women and farmers including the Sector from Indigenous Cultural Communities;

**WHEREAS**, during the General Assembly conducted last December 12, 2018 by the various Indigenous Organizations and Individuals from the tribes of Ibanag, Itawes, Yogad, Gaddang, Ifugao, Igorot, Kalinga and Agtas, they have nominated and elected **Hon. Gretchen Flores Valdez**, whose tribe comes from the native tribe in Isabela – the Ibanag tribe as confirmed by the National Commission on Indigenous People (NCIP), to be the next to occupy the seat of Indigenous People's Sectoral Representative in the Provincial Board/Sangguniang Panlalawigan of the Province of Isabela;

**WHEREAS, Hon. Gretchen Flores Valdez**, is presently the Vice President of the Mengal Woman Organization whose membership encompasses huge number of Yogad Woman – natives of Echague, Isabela and elected as one of the Regional Advisory Councils of PUNGANAY Regional I.P. organization;

**WHEREAS**, the indigenous communities is one of the sectors which the Provincial Government of Isabela (PGI) deemed to have significant representation in the Sangguniang Panlalawigan of the Province of Isabela;

**NOW THEREFORE**, in view of the above – antecedent facts, upon motion of **Hon. Delfinito Emmanuel L. Albano**, duly seconded and approved by all the members present in a session duly assembled, it was –

**RESOLVED, AS IT IS HEREBY RESOLVES: TO ADOPT A RESOLUTION CONFIRMING THE APPOINTMENT OF HON. GRETCHEN FLORES VALDEZ AS SECTORAL REPRESENTATIVE ON INDIGENOUS CULTURAL COMMUNITIES TO THE SANGGUNIANG PANLALAWIGAN, PROVINCE OF ISABELA;**


