### **RESOLUTION NO. 447 SERIES OF 2019**

**A RESOLUTION DECLARING THE ENTIRE PROVINCE OF ISABELA UNDER A STATE OF CALAMITY DUE TO THE CUMULATIVE EFFECTS OF TYPHOONS RAMON, SARAH, AND TISOY, AND TORRENTIAL RAINS BROUGHT ABOUT BY AMIHAN RESULTING TO WIDESPREAD FLOODING, AND DAMAGES TO THE PROVINCE'S AGRICULTURAL, COMMERCIAL, AND AGRO-INDUSTRIAL SECTORS, AND FOR OTHER PURPOSES**

**WHEREAS**, pursuant to Republic Act No. 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010, local government units, through their Sanggunians, have the power to declare State of Calamity in their respective territories;

**WHEREAS**, the Province of Isabela is currently in a dire state due to the effects of three (3) Typhoons, namely: Ramon; Sarah; and Tisoy which all affected the Province in immediate succession within a three-week span, particularly from November 19, 2019 to the date of this declaration;

**WHEREAS**, these Typhoons, aggravated by the onslaught of torrential rains brought about "Amihan", brought a continuous downpour of heavy rains which caused widespread loss of agricultural crops, harvests, and livelihood; and have crippled the business and operations of local businesses, especially those which rely on the produce and commerce of the local agricultural sector;

**WHEREAS**, the severe flooding caused major economic disruptions; paralyzed transportation routes to affected barangays and localities; areas have become inaccessible; displaced countless Isabeleños, and left many more stranded in their homes;

**WHEREAS**, the Provincial Government of Isabela must take prompt measures to provide the affected population with immediate and necessary succor, and to employ emergency responses to ensure their safety and welfare in this time of dire conditions;

**WHEREAS**, there exists an actual need and genuine urgency to declare the entire Province of Isabela under a State of Calamity;


**NOW THEREFORE**, premises considered, upon motion of Hon. Alfredo V. Alili, the Sanggunian, in a session duly assembled, unanimously approves to adopt: **A RESOLUTION DECLARING THE ENTIRE PROVINCE OF ISABELA UNDER A STATE OF CALAMITY DUE TO THE CUMULATIVE EFFECTS OF TYPHOONS RAMON, SARAH, AND TISOY, AND TORRENTIAL RAINS BROUGHT ABOUT BY AMIHAN RESULTING TO WIDESPREAD FLOODING AND DAMAGES TO THE PROVINCE'S AGRICULTURAL, COMMERCIAL, AND AGRO-INDUSTRIAL SECTORS, AND FOR OTHER PURPOSES**
