**A RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO PROVIDE CALAMITY RELIEF ASSISTANCE TO ALL EMPLOYEES AND OFFICIALS OF THE PROVINCIAL GOVERNMENT OF ISABELA**

**WHEREAS**, this Honorable Body has placed the entire Province of Isabela under "State of Calamity" due to the widespread devastation caused by the cumulative effects of Typhoons Ramon, Sarah, and Tisoy, which all came in immediate succession, aggravated by the onslaught of torrential monsoon rains;

**WHEREAS**, paragraph 6 of the Civil Service Commission Memorandum Circular No. 16 s. 2012 provides and enjoins every agency in the government to come up with long-term plan to address the conditions of its employees affected by natural calamity/disaster and to include in the said plan provisions for extending immediate relief or other forms of assistance to employees;

**WHEREAS**, in keeping with the policy of the Provincial Government of Isabela in promoting the welfare of all its personnel which it recognizes as indispensable in the delivery of efficient public services, it is incumbent upon the Province's leadership to help minimize the adverse effect of the prevailing economic situation and mitigate the great mental and physical suffering inflicted by these typhoons;

**WHEREAS**, in view of their pressing needs and the immediacy of the situation at hand, this Honorable Body grants the Provincial Governor with the appropriate authority to provide each Official and Regular employee of the PGI with (Php20,000.00), and Ten Thousand Pesos (Php10,000.00) for contractual and casual employees, including Legislative Support Staff of the Sangguniang Panlalawigan;

**WHEREAS**, this Body further authorizes the grant of one (1) cavan of rice to all recipients of the above Cash Relief Assistance;

**WHEREFORE**, premises considered, upon motion of Hon. Abegail V. Sable, duly approved and seconded in a session duly assembled it was –

**RESOLVED, AS IT HEREBY RESOLVES: TO ADOPT A RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO PROVIDE CALAMITY RELIEF ASSISTANCE TO ALL EMPLOYEES AND OFFICIALS OF THE PROVINCIAL GOVERNMENT OF ISABELA.**
