WHEREAS, the **Honorable NAPOLEON M. HERNANDEZ, JR** was brutally murdered on July 1, 2019 at Dagupan, San Mateo, Isabela;

WHEREAS, his death came us a shocking news to the province's populace particularly the Provincial Government of Isabela because, at this point in time, his vibrant, energetic and enthusiastic age he was meted the most drastic, inhumane and senseless punishment;
