**A RESOLUTION RESPECTFULLY ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT THE REQUEST OF THE PROVINCIAL GOVERNMENT OF ISABELA TO AVAIL FUNDS FROM THE LOCAL GOVERNMENT SUPPORT FUND – FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS FOR YEAR 2019 IN THE AMOUNT OF SEVEN MILLION FIVE HUNDRED THOUSAND PESOS (PHP7,500,000.00) TO BE UTILIZED FOR THE PROVISION OF FOOD ASSISTANCE TO FAMILIES IN CRISIS SITUATION IN THE 4<sup>TH</sup> DISTRICT OF PROVINCE OF ISABELA**

**WHEREAS**, the Province of Isabela, the second largest rice-producing province in the country, is home to a significant number of small rice farmers who are wholly dependent on the yields of rice farming;

**WHEREAS**, the sudden, sharp drop in the gate prices of palay due to the passage of the Rice Tarrification Law triggered a dire ripple effect on the economy of the Province, causing severe economic losses to our local rice industry and stress to our local rice farmers;

**WHEREAS**, these instances have incapacitated and debilitated most of our small farmers to continue farming due to fears of continuous losses and further submersion to debts;

**WHEREAS**, Budget Circular No. 119 of the Department of Budget and Management (DBM) provides **“GUIDELINES ON THE RELEASE AND UTILIZATION OF LOCAL GOVERNMENT SUPPORT FUND – FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-FA TO LGUs) FOR THE CURRENT YEAR (CY) 2019 GENERAL APPROPRIATIONS ACT”**, and referred therein are the projects and programs eligible for funding from the LGSF-FA to LGUs;

**WHEREAS**, the Provincial Government of Isabela provides its people, especially those who are financially-challenged, with a food assistance program to help alleviate their economic stresses;

**WHEREAS**, the Provincial Government of Isabela aspires to avail funds from the LGSF-FA to LGUs in the amount of **SEVEN MILLION FIVE HUNDRED THOUSAND PESOS (Php7,500,000.00)** which shall be solely utilized for the provision of its food assistance program;

**WHEREAS**, the food assistance program to which the LGSF-FA to LGUs will be utilized, if granted, falls among those projects and programs eligible for funding from the LGSF-FA to LGUs, particularly paragraph (b)(vi) of the aforesaid Budget Circular;

**WHEREFORE**, premises considered, upon motion of Hon. Edgar R. Capuchino, duly seconded and unanimously approved by the members of this Body, it was –




