WHEREAS, the Development Bank of the Philippines (DBP) intends to distribute the benefits of the Virginia and Burley Tobacco Excise Taxes to farmer-beneficiaries;

WHEREAS, the distribution of the benefits under the above excise tax shall be initiated by way of a Memorandum of Agreement (MOA) between the DBP and the PGI, and shall be given to the farmer-beneficiaries thru a settlement account with DBP;
