A RESOLUTION ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT THE PROPOSED PROJECTS OF THE PROVINCIAL GOVERNMENT OF ISABELA FOR FUNDING UNDER LOCAL GOVERNMENT SUPPORT FUND – FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS

WHEREAS, it is the declared policy of the National Government to significantly increase public spending on infrastructure projects in line with President Rodrigo R. Duterte's "Build, Build, Build (BBB) Program" that aims to usher in the country's "Golden Age of Infrastructure";

WHEREAS, in advancement and support of President Duterte's BBB Program, the Provincial Government of Isabela (PGI) is desirous to implement key infrastructure projects projected to greatly accelerate the economic development of the Province. Such projects are as follows:

1. Rehabilitation/Upgrading of Ilagan – Divilacan Provincial Road, Ilagan & Divilacan Isabela, Isabela;
2. Improvement/Rehabilitation of Jct. National – Lullutan – Quirino – San Pedro – Jct. National Provincial Road, Ilagan & Quirino, Isabela;
3. Improvement/Rehabilitation of Jct. National Harana – Marabulig Provincial Road, Luna and Cauayan City, Isabela;
4. Supply and Installation of Street Lighting of different barangays Cabagan, San Pablo and Cauayan City, Isabela; and
5. Improvement/Rehabilitation of Jct. Provincial Sa Luis – Villa Concepcion Provincial Road, Cauayan City, Isabela.

WHEREAS, the PGI is seeking the support and backing of the Department of Budget and Management to finance the above infrastructure projects thru the latter's Local Government Service Funds – Financial Assistance to Local Government Units (LGSF – FA to LGUs);

WHEREAS, it is a condition precedent in the submission of requests for project funding from the LGSF – FA to LGUs the passage of a Sanggunian resolution endorsing to the Department of Budget and Management the concerned LGU's proposed projects;

WHEREAS, this Body forward sits full support to the BBB Program of President Duterte's Administration, and unanimously endorses the funding request of the PGI to DBM;

NOW THEREFORE, upon motion of the Hon. Alfredo V. Alili, duly seconded and approved by all the members present in a session duly assembled it was –
