**WHEREAS**, as provided in RA 9679, it is the policy of the State to establish and develop, promote and integrate a nationwide sound and viable tax – exempt mutual provident savings system suitable to the needs of the employed and other earning groups, and to motivate them to better plan and provide for their housing needs, by membership in the Home Development Mutual Fund, with mandatory contributory support of the employers in the spirit of social justice and pursuit of national development;

**WHEREAS**, Pag – Ibig Fund known as Home Development Mutual Fund was created to provide decent and affordable housing for its members and those gainfully employed individuals who may opt to enroll themselves as members of the institution;

**WHEREAS**, the Provincial Government of Isabela is cognizant of the significant contribution and role of our Barangay officials for being the key front-liners in the delivery of basic needs to the community. Hence, these officials equally deserve the foregoing benefits and programs;

**WHEREAS**, pursuant to the above policy, the Provincial Government of Isabela urges all Officials of Barangay Government Units, specifically: (a) Punong Barangay; (b) Sangguniang Barangay Members; (c) Sangguniang Kabataan Chairman (d) Barangay Secretary; (e) Barangay Treasurer to become a member of the Home Development Mutual Fund;

**WHEREFORE**, upon motion of **Hon. Marco Paolo A. Meris**, duly approved and seconded by all the members present in session duly assembled it was –


