EXPLANATORY NOTE

WHEREAS, Republic Act (RA) No. 11469 (the Bayanihan to Heal as One Act) granted the President the power to adopt various temporary emergency measures to respond to crisis brought about by the Coronavirus Disease 2019 (COVID-19) pandemic;

WHEREAS, Section 4(g) of the said Act empowered the President to ensure that all local government units (LGUs) are acting within the letter and spirit of all the rules, regulations and directives issued by the National Government pursuant to the said law, and are implementing standards of Community Quarantine consistent with what the National Government has laid down for the subject area, while allowing the LGUs to continue exercising their autonomy on matters undefined by the National Government or are within the parameters it has set, and are fully cooperating towards a unified, cohesive and orderly implementation of the national policy to address COVID-19;

WHEREAS, to effectively carry out the said measures, the National Government allocated funds to augment the resources of the local government units through the Bayanihan Grant to Provinces (BGP);

WHEREAS, BGP shall be released to all provinces to be used as augmentation to the funding requirements for the operation of provincial, district, and other local

WHEREAS, Section 321 of the Local Government Code authorizes the enactment of an ordinance providing for Supplemental Budget when supported by funds actually available as certified by the local treasurer by new revenue sources;

WHEREAS, the DBM has issued Local Budget Circular No. 126 dated April 13, 2020 which provides guidelines on the release and utilization of the Bayanihan Grant to Provinces (BGP);

WHEREAS, pursuant to the abovementioned Circular, for easy monitoring/tracking of the utilization of the allocation of the province, a Special Account in the General Fund (SAGF) for the BGP shall be created in accordance with Section 313 of RA No. 7160 through inclusion in the appropriation ordinance authorizing a supplemental budget covering the BGP;

WHEREFORE, upon motion of Hon. Faustino U. Dy IV, duly seconded and unanimously approved by all Members present on this session duly assembled, it was
