WHEREAS, Republic Act (RA) No. 11469 (the Bayanihan to Heal as One Act) granted the President the power to adopt various temporary emergency measures to respond to crisis brought about by the Coronavirus Disease 2019 (COVID-19) pandemic;

WHEREAS, Section 4(g) of the said Act empowered the President to ensure that all local government units (LGUs) are acting within the letter and spirit of all the rules, regulations and directives issued by the National Government pursuant to the said law, and are implementing standards of Community Quarantine consistent with what the National Government has laid down for the subject area, while allowing the LGUs to continue exercising their autonomy on matters undefined by the National Government or are within the parameters it has set, and are fully cooperating towards a unified, cohesive and orderly implementation of the national policy to address COVID-19;

WHEREAS, to effectively carry out the said measures, the National Government allocated funds to augment the resources of the local government units through the Bayanihan Grant to Provinces (BGP);

WHEREAS, the Department of Budget and Management issued Local Budget Circular No. 126 dated April 13, 2020 providing the guidelines on the release and utilization of the BGP;

WHEREAS, Section 3.7 of the abovementioned Circular directs Sangguniang Panlalawigans to create a Special Account in the General Fund for the BGP in accordance with Section 313 of RA No. 7160 through inclusion in the appropriation ordinance authorizing a supplemental budget covering the BGP;

WHEREAS, presented for the consideration of this Body is the proposed Supplemental Budget No. 01 for Fiscal Year 2020 of the Provincial Government of Isabela, submitted by the Office of the Provincial Governor as proffered by the Provincial Development Council in accordance with the said DBM Circular and the Local Government Code, outlining the anti-COVID19 programs, projects, and activities of the Provincial Government of Isabela to be funded from its share in the BGP in the amount of Php136,776,550.00;

WHEREFORE, upon motion of Hon. Faustino U. Dy IV, duly seconded and approved by all the members present in a session duly assembled, it was –
