A RESOLUTION CONFIRMING THE APPOINTMENT OF RETIRED COLONEL JIMMY U. RIVERA SR. AS PROVINCIAL GOVERNMENT DEPARTMENT HEAD OF THE PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE EFFECTIVE APRIL 14, 2020

WHEREAS, as per certification of the Provincial Human Resources and Management Office, the position of Provincial Disaster Risk Reduction and Management Office is vacant;

WHEREAS, the Provincial Governor approved the appointment of Retired Colonel Jimmy U. Rivera Sr. to the position of Provincial Disaster Risk Reduction and Management Officer;

WHEREAS, Article 119 of the Implementing Rules and Regulations of the Local Government Code provide that heads of offices and departments in the LGUs appointed by the local chief executive concerned must be "concurred upon by a majority of all the members of the Sanggunian";

WHEREAS, the National Disaster Risk Reduction and Management Council, the Department of Interior and Local Government, Department of Budget and Management, and the Civil Service Commission issued Joint Memorandum Circular No. 2014-01 which established the minimum qualification standards, among others, for the position of Provincial Disaster Risk Reduction and Management Officer, viz:

Education - Master's Degree

Experience - 5 years in position involving management

and supervision, one year of which is relevant to Disaster Risk Reduction and Management

Training - 32 hours of training in management and supervision

on Disaster Risk Reduction and Management

Eligibility - Career Service Professional/ 2nd Level Eligibility

WHEREAS, as per documents submitted to this Honorable Body providing details to the qualifications, eligibilities, and employment experience of Retired Colonel Jimmy U. Rivera, his appointment to the position of Provincial Risk Reduction and Management Officer is determined to be in order as he met - even surpassed, the minimum qualification standards established by the above Joint Memorandum Circular, and none of the disqualifications established by law;

WHEREFORE, premises considered, upon motion of Hon. Delfinito Emmanuel L. Albano, and upon unanimous accord of this August Body, it was -
