WHEREAS, the acceptance of the seeds requires the execution of a Deed of Donation between the Provincial Government of Isabela and PRRI – Isabela Branch;


WHEREFORE, premises considered, upon motion of Honorable Adrian Philip S. Baysac, duly approved and seconded in a session duly assembled it was –
