**EXPLANATORY NOTE**

**WHEREAS**, this Honorable Body passed Ordinance No. 022, series of 2020, which authorized and approved the 2020 Annual Budget of the Provincial Government of Isabela (PGI);

**WHEREAS**, the PGI 2020 Annual Budget appropriated funds for the "Conditional Matching Grant to Province (CMGP)" and "Other Development Projects" amounting to Twenty Five Million Pesos (Php25,000,000.00) and Fifty Four Million Four Hundred Three Thousand Six Hundred Eighty Pesos (Php54,403,680.00), respectively, thus totaling Seventy Nine Million Four Hundred Three Thousand Six Hundred Eighty Pesos (Php79,403,680.00);

**WHEREAS**, on August 06, 2020, the Office of the Provincial Governor submitted a Letter addressed to this Honorable Body requesting that the amount of Seventy Nine Million Four Hundred Three Thousand Six Hundred Eighty Pesos (Php79,403,680.00) appropriated for the "Conditional Matching Grant to Province (CMGP)" and "Other Development Projects" be reprogrammed to various accounts for the implementation of numerous infrastructure projects, as provided below, citing compliance to a Department of Budget and Management (DBM) Review-Action requiring identification/breaking down into specific/project components indicating the activities/programs to be undertaken and the project site/location;






