WHEREAS, the PGI and the DSWD executed a Memorandum of Agreement, duly approved by this Honorable Body, in which it was agreed that the DSWD shall transfer funds in favor of the PGI subject to the condition that the PGI properly utilize such funds for the efficient and expeditious distribution of aid under the AICS Program to target beneficiaries in the Province of Isabela;

WHEREAS, in adherence and in faithful compliance to the agreement of both institutions, this Honorable Body hereby extends the appropriate authority to the PGI to download or receive funds from the DSWD-RO2 to be utilized for the expeditious distribution of aid under the AICS Program to target beneficiaries in the Province of Isabela;

WHEREFORE, premises considered, upon motion of Honorable Alfredo V. Alili, duly approved and seconded in a session duly assembled it was –
