WHEREAS, His Excellency, President Rodrigo R. Duterte, issued Presidential Proclamation No. 929, series of 2020, which placed the entire Philippines under State of Calamity due to the entry and spread of COVID-19 in the country;

WHEREAS, on March 24, 2020, President Rodrigo R. Duterte signed into law Republic Act No. 11494 or the "Bayanihan to Recover as One Act" which granted the Office of the President additional powers and authority for the swift mobilization of government assets and resources to resolve the pandemic;

ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA (PGI) A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH – CAGAYAN VALLEY CENTER FOR HEALTH DEVELOPMENT (DOH-CVCHD) FOR THE RECEPTION OF FUNDS TO BE UTILIZED FOR THE GRANT OF ACTIVE HAZARD DUTY PAY TO ELIGIBLE PGI HEALTH WORKERS

WHEREAS, pursuant to Section 4(w) of Republic Act No. 11494, Administrative Order No. 35 was issued by the Office of the President authorizing the grant of Active Hazard Duty Pay (AHDP) to Human Resources for Health (HRHs) serving in the frontlines during the state of the national emergency;

WHEREAS, pursuant to Section 4(h) of the same Act, Administrative Order No. 36 was issued by the Office of the President authorizing COVID-19 Special Risk Allowance (SRA) to private and public health workers directly catering to or in contact with COVID-19 patients during the State of National Health Emergency;

WHEREAS, the Department of Health (DOH) and the Department of Budget and Management (DBM) issued Joint Circular No. 1 and No. 2, both series of 2020, and dated November 25, 2020, which provided the guidelines on the grant of AHDP and COVID-19 SRA to eligible health workers, respectively;

WHEREAS, as part of the PGI's and the DOH-CVCHD's joint endeavor to express gratitude and to recognize the invaluable sacrifices of local health workers to resolve this health crisis, and in adherence to the directives of the above-mentioned Joint Circulars, both agencies aspire to enter into a Memorandum of Agreement in which the DOH-CVCHD shall transfer funds to the PGI, in the amount of Php16,170,828.68, for the grant of ADHP and COVID-19 SRA to eligible PGI health workers;

WHEREAS, this Honorable Body deems the proposed Memorandum of Agreement between the PGI and the DOH-CVCHD for the grant of ADHP and COVID-19 SRA to eligible PGI health workers to be beneficial and advantageous to the Isabeleño people;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –


