WHEREAS, the Provincial Government of Isabela (PGI) in the exercise of its corporate power may enter into contracts and exercise such other powers as granted to corporations subject to the limitations provided under the Local Government Code and other applicable laws;

WHEREAS, considering the rapid development of technology the PGI ensures that such is in conformity to a balanced and healthful ecology in accord with the rhythm and harmony of nature;


