Orpilla of East Avenue Medical Center, to ensure the availability of skilled health professionals in the Province of Isabela who will prioritize individuals from poor and underserved areas;

**WHEREAS**, this Body acknowledges the benefits and advantages that the Province will gain, particularly in ensuring the availability of health professionals and the expansion of its medical initiatives, in the deployment of Dr. Orpilla in Cauayan District Hospital and as such extends its concurrence to the proposed Memorandum of Agreement;

**WHEREFORE**, premises considered, upon motion of Hon. Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled it was –


