WHEREAS, the local hog-raising and pork-selling industries play a crucial role in the economy of the Province as it provides a significant number of Isabeleños with a source of livelihood and income;

WHEREAS, the possible entry of the African Swine Fever (ASF) in the Province poses a considerable threat to such industries as even the slightest fear or news of an outbreak affects the price and demand of pork products;

WHEREAS, ASF may also pose grave threat to public health should our local government turn a blind eye or implement lackluster actions to prevent its entry or contain its spread in the Province;

WHEREAS, it is imperative for the Provincial Government of Isabela to undertake all necessary measures to prevent the entry of ASF in the Province, or if such already occurred, to take all essential steps to contain and curb its spread;

WHEREAS, this Honorable Body guarantees its cooperation and participation to the programs and courses of action of the Provincial Governor in his objective to prevent the entry and to contain the spread of ASF in the Province;

WHEREAS, authorization is given to the Provincial Governor, Honorable Rodolfo T. Albano III, to utilize any and all available and permissible resources to advance all necessary courses of action to prevent the entry and to contain the spread of ASF in the Province;

WHEREAS, this Honorable Body calls the attention and assistance of all local government units in the Province to work together in preventing the entry of ASF in the Province, and to execute strict measures in monitoring and containing actual or possible ASF-stricken hogs in their respective jurisdictions.


WHEREFORE, upon motion of Honorable Adrian Philip S. Baysac, duly approved and seconded of all the members in a session duly assembled it was –
