**WHEREAS**, it is the policy and priority of the Provincial Government of Isabela (PGI) to provide Isabeleños with quality health care and effective medical service;

**WHEREAS**, the PGI acknowledges the need to advance and promote the modernization of its health facilities to effectively address the health concerns and medical needs of its constituents;

A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA (PGI) A MEMORANDUM OF AGREEMENT WITH GCMED PHARMACEUTICAL DISTRIBUTOR FOR THE PROVISION OF LABORATORY EQUIPMENT, ACCESSORIES, AND SUPPLIES TO PGI HOSPITALS

**WHEREAS**, the Office of the Provincial Governor sent a Letter to the Sangguniang Panlalawigan requesting this Honorable Body to grant Honorable Rodolfo T. Albano III with authority to represent and bind the Provincial Government of Isabela in a Memorandum of Agreement (MOA) with GCMED Pharmaceutical Distributor. The Agreement pertains to the provision of a set of laboratory equipment and accessories for each PGI Hospital free-of-charge. Attached therewith is the draft MOA;

**WHEREAS, GCMED Pharmaceutical Distributor (GCMED for brevity)**, a company duly organized and existing under Philippines laws, is a private entity engaged in the business of providing laboratory equipments and accessories, and medical supplies;

**WHEREAS, GCMED expressed their desire to provide PGI Hospitals free use of its laboratory equipments and accessories, briefly described as follows:**

- 1 unit Fully Automated Chemistry Analyzer and accessories;
- 1 unit GH580 Fully Automated Hematology Analyzer;
- 1 unit GEPP320 Fully Automated Hematology Analyzer and accessories;
- 1 unit Electrolyte Analyzer;
- 4 Finecare Immunology POCT; and
- 1 unit Finecare Immunology.

**WHEREAS**, as provided in the submitted draft MOA, it was stipulated that in exchange for the free use of the above laboratory equipments, the PGI must exclusively purchase from **GCMED** all reagents/consumables for the said equipments, including the initial one-year supply, throughout the duration of the Agreement which shall be five (5) years, unless terminated at an earlier date;

**WHEREAS**, this Honorable Body finds that the other stipulations provided in the submitted draft Memorandum of Agreement fair and reasonable;

**WHEREAS**, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

**WHEREAS**, this Honorable Body confers upon the Provincial Governor, Honorable Rodolfo T. Albano III, the requisite authority to sign in behalf of the Provincial Government of Isabela the MOA with GCMED for the provision of laboratory equipments and accessories and procurement of reagents/consumables, subject to observance of pertinent procurement, accounting, and auditing laws, rules, and regulations;

**WHEREFORE**, premises considered, upon motion of Hon. Emmanuel Joselito B. Añes, duly approved and seconded in a Session duly assembled, it was –




