A RESOLUTION DECLARING SANGGUNIANG PANLUNGSOD ORDINANCE NO. 2019-261 OF THE CITY GOVERNMENT OF CAUAYAN, ISABELA AS INTRA VIRES

WHEREAS, on December 17, 2019, the City Government of Cauayan, Isabela adopted and approved Sangguniang Panlungsod Ordinance No. 2019-261 titled "Ordinance Authorizing the Proposed Borrowing of the City of Cauayan, Province of Isabela in the Amount of One Hundred Fifty Million Pesos (₱150,000,000.00) to Fund the Construction of a Multi-Purpose Building and Road Projects of the LGU";

WHEREAS, on May 06, 2020, the Sangguniang Panlungsod of the City Government of Isabela furnished the Office of the Secretary to the Sangguniang Panlalawigan a copy of the said Ordinance for review of the Sangguniang Panlalawigan;

WHEREAS, this Honorable Body, thru the Office of the Secretary to the Sangguniang Panlalawigan, furnished the Provincial Budget Officer a copy of the said City Ordinance for the latter's assessment and evaluation, pursuant to relevant DBM Guidelines;

A RESOLUTION DECLARING ORDINANCE NO. 2019-261 OF THE CITY GOVERNMENT OF CAUAYAN, ISABELA AS INTRA VIRES

WHEREAS, Section 56 of the Local Government Code (LGC) establishes the authority of the Sangguniang Panlalawigan to review Component City and Municipal Ordinances or Resolutions for the purpose of determining if such is beyond the scope of the powers conferred by law;

WHEREAS, after careful review of the said City Ordinance, this Honorable Body determined that:

- The amount of the loan and the terms and the conditions for payment thereof was made with proper authorization and confirmation from the Sangguniang Panlungsod, consistent with Section 455 par. 1(vi) in relation to Section 458(a) of the LGC;
- The projects to which the proceeds of the loan shall be appropriated are public in nature, and are consistent with the 2020 Local Development Plan and 2020 Public Investment Program of the City Government of Cauayan, Isabela; and
- 3. That as per the recommendation of the Provincial Budget Office, the Loan must comply with the condition set under Section 324 (b) of the LGC which states that the amount of Appropriations for debt servicing shall not exceed twenty percent (20%) of the regular income of the LGU.

WHEREAS, in view of our findings, this Honorable Body deems the City Ordinance as within the powers granted by law to the City Government Unit;

WHEREFORE, premises considered, upon motion of Hon. Marco Paolo A. Meris, duly approved and seconded in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES, TO ADOPT A RESOLUTION DECLARING ORDINANCE NO. 2019-261 OF THE CITY GOVERNMENT OF CAUAYAN, ISABELA AS INTRA VIRES:
