A RESOLUTION ADOPTING THE ANNUAL WORK PROGRAM (AWP) OF THE YEAR 2020 OF THE PROVINCE OF ISABELA IN RESPONSE TO COVID-19 PUBLIC HEALTH EMERGENCY TO BE FUNDED THROUGH THE PROVINCIAL SHARE FROM THE ENERGY REGULATIONS NO. 1-94 (ER 1-94) FUND

WHEREAS, Energy Regulations 1-94 was promulgated by the Department of Finance to operationalize the implementation of giving direct benefits to the province, city or municipality that Hosts the energy resources and energy generating facilities;

WHEREAS, Host Communities are entitled to a share of one centavo per kilowatt hour (Php 0.01/kw) of the total electricity sales as financial benefit to be allocated as Electrification Fund (EF), Development and Livelihood Fund (DLF) and Reforestation, Watershed Management, Health and/or Environment Enhancement Fund (RWMHEEF);

WHEREAS, Republic Act No. 9136 Implementing Rules and Regulations as amended by the Department Circular No. DC2018-08-0021 provides for priority projects qualified to be funded from the ER 1-94 Funds;

WHEREAS, in view of the issuance of Proclamation No. 922, Declaring a State of Public Health Emergency, the government recognized the need to provide immediate assistance to Host Communities to enhance their health services;

WHEREAS, on April 6, 20120, the DOE issued Department Circular No. 2020-04-0008, "Rationalizing the Utilization of ER 1-94 Funds by Host Local Government Units in Response to COVID-19 Public Health Emergency", suspending the application and implementation of eligible projects as provided for in Section 10.3 of Department Circular No. DC2018-08-0021, and directs the utilization and disbursement of the ER 1-94 Funds for the management of the effects of COVID-19 pandemic by Host Communities;

WHEREAS, SN Aboitiz Power (SNAP) Magat Inc. located in Ramon, Isabela is a Generation Company hosted by the province;

WHEREAS, based on records of SNAP, for the year 2020, the estimated accrued financial benefits due to the Province of Isabela are as follows:

1. Magat Hydroelectric Power Plant
 - DLF - Php 416,691.84
 - RWMHEEF - Php 416,691.84
 - EF - Php 833,383.68
2. Maris South Canal Power Plant
 - DLF - Php 60,813.13
 - RWMHEEF - Php 60,813.13
 - EF - Php 121,626.26

WHEREAS, pursuant to DC No. 2020-04-0008, the Provincial Government of Isabela identified the procurement of hygiene kits and disinfectants to be used by healthcare workers as one of its priority projects to combat the spread of COVID-19 pandemic;

WHEREAS, presented for the consideration of this Body, is the **Annual Work Program (AWP)** outlining the anti-COVID19 programs, projects, and activities of the Provincial Government of Isabela to be funded from its share in the ER 1-94 Funds;

WHEREAS, the **AWP** is in line with the intents and purposes of RA 11469 entitled "Bayanihan to Heal as One Act";

NOW THEREFORE, upon motion of **Hon. Faustino U. Dy, IV** duly seconded and approved by all members present in a session duly assembled, it was-
