WHEREAS, Pitmaster has selected the Governor Faustino N. Dy Memorial Hospital (GFNDMH) as a beneficiary of its Medical Assistance Program. Accordingly, medical aid, financial support, and/or other forms of medical interventions including access to medical equipment of Pitmaster will be provided free of charge to patients of GFNDMH;

WHEREAS, the implementation of Pitmaster Foundation's Medical Assistance Program in GFNDMH requires the execution of a Memorandum of Agreement between such organization and the Provincial Government of Isabela;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous to the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the PGI;

WHEREFORE, premises considered, upon motion of Hon. Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled it was –
