A RESOLUTION DECLARING THE ENTIRE PROVINCE OF ISABELA UNDER A STATE OF CALAMITY DUE TO THE CUMULATIVE EFFECTS OF TYPHOONS ROLLY, SIONY, AND ULYSSES, AND TORRENTIAL RAINS

WHEREAS, Local Government Units, through their Sanggunians, are duly empowered by law to declare a State of Calamity in their respective jurisdictions;

WHEREAS, the Province of Isabela is experiencing widespread devastation due to the occurrence of torrential rains and the successive entry of Typhoons Rolly, Siony, and Ulysses within a twelve-day period, particularly: Typhoon Rolly on November 01, 2020; Typhoon Siony on November 06, 2020; and Typhoon Ulysses on November 12, 2020;

WHEREAS, such events brought heavy rainfall that caused rapid and extensive flooding in various areas of the Province. Resultantly, countless houses, crops, and farmlands were submerged; various roads and bridges became impassable; numerous establishments closed operations; and a myriad of Isabeleños have been, and are still being, evacuated from their homes;

WHEREAS, as of this moment, all Provincial, Municipal, City, and Barangay emergency response personnel and assets are being stretched to absolute limits as they tend to innumerable Isabeleños seeking rescue from their flooded homes;

WHEREAS, recognizing the widespread devastation caused by the foregoing to the Province's agriculture, economy, and to the lives of countless Isabeleños, and its potential to facilitate the spread of COVID-19 in affected areas, this Honorable Body, by virtue of the powers provided by law and upon recommendation of the Local Disaster Risk Reduction and Management Council with compliance to documentary requirements set forth by pertinent laws, rules, and orders, hereby declares the entire Province of Isabela under a State of Calamity;

WHEREAS, such declaration will, among others, afford the Provincial Government of Isabela and all local government units within its jurisdiction, the opportunity to utilize all appropriate funds to further strengthen their response and relief efforts to affected people in their respective territories;

WHEREFORE, premises considered, upon motion of Hon. Alfredo V. Alili, duly approved and seconded in a Special Session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING THE ENTIRE PROVINCE OF ISABELA UNDER A STATE OF CALAMITY DUE TO THE CUMULATIVE EFFECTS OF TYPHOONS ROLLY, SIONY, AND ULYSSES, AND TORRENTIAL RAINS;

RESOLVED FINALLY, that a copy of this Resolution be furnished to: the Provincial Governor, Hon. Rodolfo T. Albano III; and the Provincial Disaster Risk Reduction and Management Officer, Mr. Jimmy U. Rivera, for their guidance and further action; and the Provincial Information Officer, Atty. Elizabeth C. Binag, for its dissemination to concerned government departments and offices and in appropriate social media platforms.
