ALBANO III, THE AUTHORITY TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH ISABELA LA SUERTE RICE MILL CORPORATION FOR THE REMITTANCE OF DEVELOPMENT AND LIVELIHOOD FUND (DLF) AND REFORESTATION, WATERSHED MANAGEMENT, HEALTH AND/OR ENVIRONMENT ENHANCEMENT FUND (RWMHEEF) UNDER THE EPIRA LAW

WHEREAS, Section 66 of Republic Act No. 9136 otherwise known as Electric Power Industry Reform Act of 2001 mandates the Generation Companies (GenCos) and/or Energy Resources Developers to provide financial benefits under ER 1-94 equivalent to one centavo per kilowatt-hour (P0.01/kWh) of its total electricity sales to the Host region, province, city or municipality and barangay;

WHEREAS, Section 4 of Rule 29 (A) of the EPIRA-IRR states that the benefits provided under ER 1-94 shall be allocated for the Electrification Fund (EF), Development and Livelihood Fund (DLF) and for the Reforestation, Watershed Management, Health and/or Environment Enhancement Fund (RWMHEEF);

WHEREAS, Section 7 of DC2018-08-0021 provides that the EF shall be remitted by GenCos and/or Energy Resources Developers to the DUs, while the DLF and RWMHEEF shall be remitted to Host LGUs and ICCs/IPs, in a manner provided for by DC2018-08-0021;

WHEREAS, Isabela La Suerte Rice Mill Corporation is a 5 MW Biomass Power Plant located at San Pedro-San Pablo, Aurora, Isabela;

WHEREAS, to enforce the immediate provision of financial benefit as Host Province, there is a need to enter into a Memorandum of Agreement for the remittance of Development and Livelihood Fund (DLF) and Reforestation, Watershed Management, Health and/or Environment Enhancement Fund (RWMHEEF);

WHEREAS, Section 465(I)(vi) of the LGC empowers the Provincial Governor to represent the Provincial Government in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, premises considered, upon motion of Hon. Alfredo V. Alili, duly approved and seconded in a session duly assembled, it was-
