ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE LOCAL GOVERNMENT UNIT OF REINA MERCEDES, ISABELA THAT WILL GRANT THE LATTER FUNDS IN THE AMOUNT OF FORTY MILLION PESOS TO BE USED FOR THE PURCHASE OF A PARCEL OF LAND IN WHICH A PUBLIC MARKET, TRANSPORT TERMINAL, AND HOSPITAL WILL BE CONSTRUCTED**

**WHEREAS**, the Provincial Government of Isabela is committed in attaining comprehensive, lasting, and sustainable prosperity in the entire Province of Isabela;

**WHEREAS**, in line with this commitment, the Provincial Government of Isabela extends ample and appropriate support to all local government units within its authority in order to accelerate their economic development and to upgrade the quality of life in their respective jurisdictions;

**A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE LOCAL GOVERNMENT UNIT OF REINA MERCEDES, ISABELA THAT WILL GRANT THE LATTER FUNDS IN THE AMOUNT OF FORTY MILLION PESOS TO BE USED FOR THE PURCHASE OF A PARCEL OF LAND IN WHICH A PUBLIC MARKET, TRANSPORT TERMINAL, AND HOSPITAL WILL BE CONSTRUCTED**

**WHEREAS**, the Local Government Unit of Reina Mercedes, Isabela (*LGU Reina Mercedes for brevity*) sought the assistance of the Provincial Government of Isabela in the purchase of a certain parcel of land located in Napaccu Pequeño, Reina Mercedes, Isabela;

**WHEREAS**, LGU Reina Mercedes undertakes to construct a Public Market, Transport Terminal, and Hospital in the said parcel of land if their purchase thereof comes to fruition;

**WHEREAS**, the Provincial Governor, Honorable Rodolfo T. Albano III, acknowledged the request of LGU Reina Mercedes and expressed his favorable decision thereto. Consequently, the Honorable Governor submitted a Letter addressed to this Honorable Body requesting for authority to represent the Provincial Government of Isabela in the signing of a Memorandum of Agreement with LGU Reina Mercedes that will grant the latter funds worth 40 Million Pesos which will be used for the purchase of the aforesaid parcel of land;

**WHEREAS**, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

**WHEREAS**, this Honorable Body recognizes the various benefits and advantages that the citizens of Reina Mercedes and the entire Province of Isabela will gain from this undertaking. Accordingly, the request of the Honorable Governor to be granted with authority to represent the Provincial Government of Isabela in the execution of the Agreement is hereby granted.

**WHEREFORE**, premises considered, upon motion of Honorable Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled it was –

**RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T.
